Mortgagor shall name Mortgagee as an additional insured or loss payee on all such policies which policies shall contain a 30-day written notice of cancellation clause in favor of Mortgagee.
- 4. To perform all the covenants on the part of Mortgager to be performed under the provisions of any prior mortgage, and upon failure of Mortgagor to perform such covenants, Mortgagee herein may at its option do so. Mortgagee shall have a claim against Mortgagor for all sums so paid by it for the Mortgagor plus interest as hereinafter provided; it being specifically understood that although Mortgagee may take such curative action, Mortgagor's failure to comply with any of the covenants of such prior mortgage shall constitute a breach of a condition of this Mortgage.

  5. To make no sale or transfer of the legal title to the mortgaged property or any equitable interest therein without obtaining prior written consent of Mortgagee. Mortgagee is under no obligation to grant consent, other than as may be required by federal law

Mortgagee shall be entitled to collect in such proceeding all costs and disbursements to which Mortgagee may become entitled by law in connection with such foreclosure proceeding, including but not limited to Mortgagee's attorney fees to the extent not permitted by applicable law, the costs of updated title searches of title insurance, and the costs of any environmental tests, studies and assessments deemed necessary by Mortgagee
