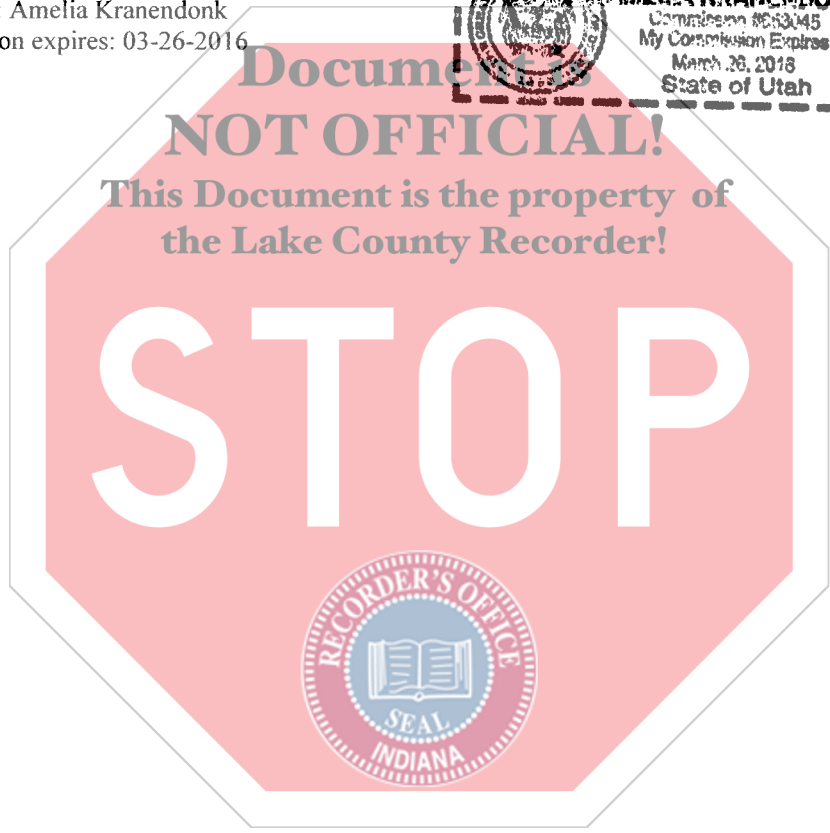
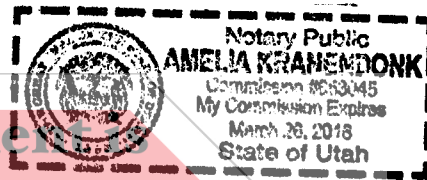


EXHIBIT "A"
LEGAL DESCRIPTION

Part of Lot 85 in Briar Cove Subdivision, Phase 1, in the Town of Schererville, Indiana, as per plat thereof, recorded in Plat Book 92 page 79, in the Office of the Recorder of Lake County, Indiana, which part of said Lot 85 is described as follows: Beginning at the Southwesterly corner of said Lot 85; thence South 68 degrees 46 minutes 14 seconds East, along the Southerly line of said lot, 130.00 feet to the Southeast corner of said Lot 85; thence Northerly, along the curved Easterly line of said Lot 85 an arc distance of 65.08 feet; thence North 77 degrees 17 minutes 20 seconds West, 130.00 feet to a point on the curved Westerly line of said Lot 85; thence Southerly, along the curved Westerly line of said lot, an arc distance of 45.76 feet to the point of beginning.
