GLENN BULOW, and after being duly sworn on his oath, states as follows:

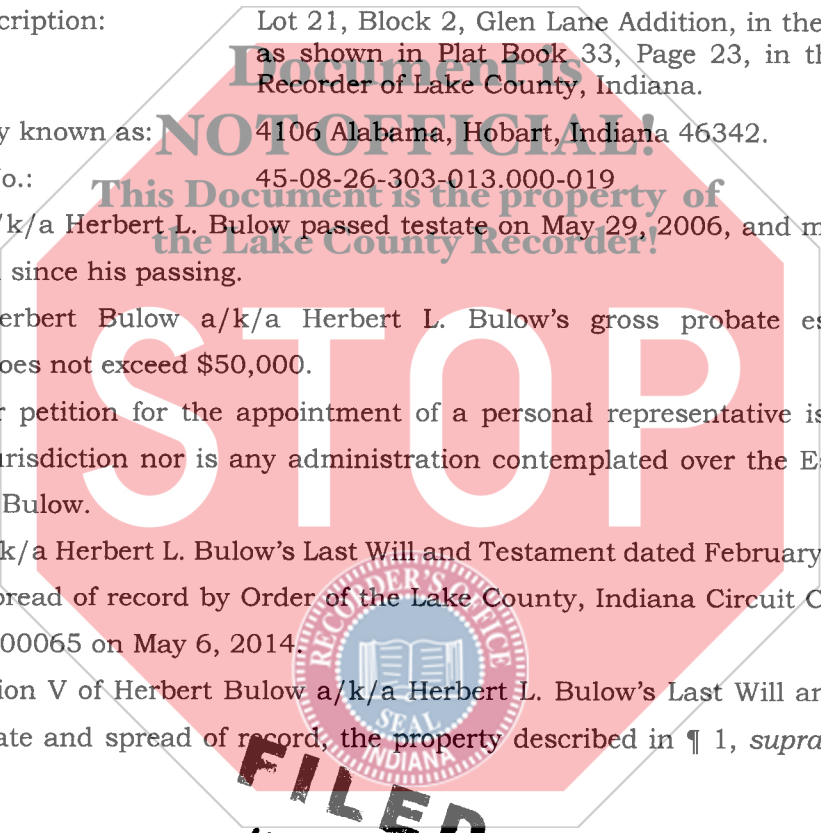
1. This affidavit is intended to correct the Affidavit of Heirship recorded on May 21, 2014 as Document No.: 2014 029070.

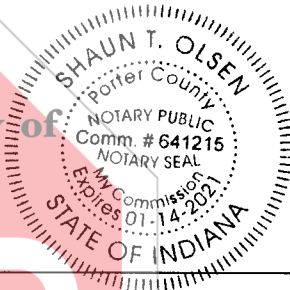
