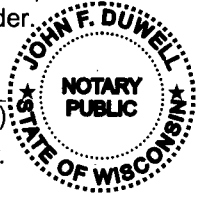

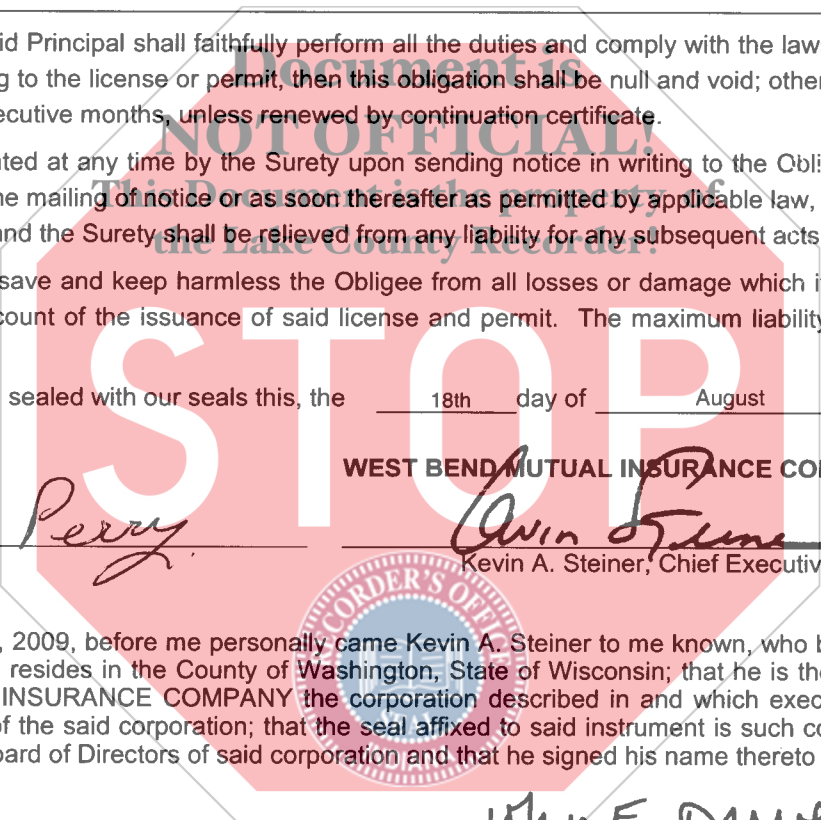


**Power of Attorney**
