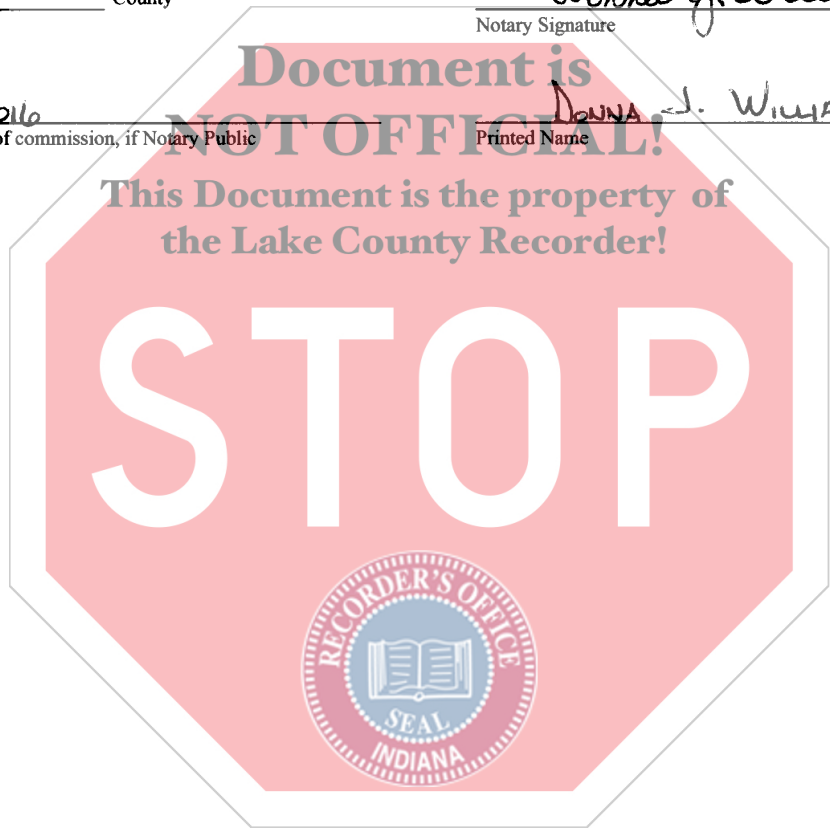

**ARTICLE IV – OFFICERS – Section 12.
