thirty days thereafter, liability hereunder shall terminate as to subsequent acts or omissions of the Principal.

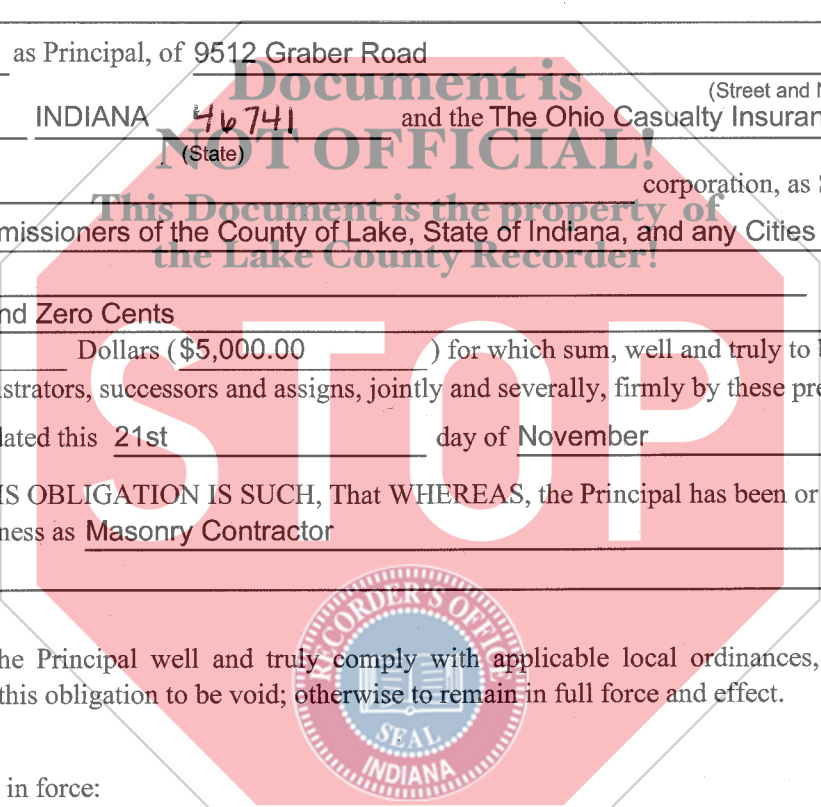
