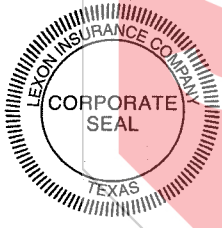
THE CONDITION OF THIS OBLIGATION IS SUCH, that whereas, the Principal has been licensed as a General Contractor by the Oblige.

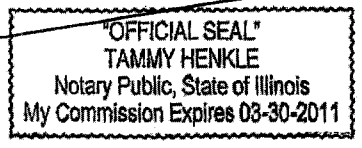

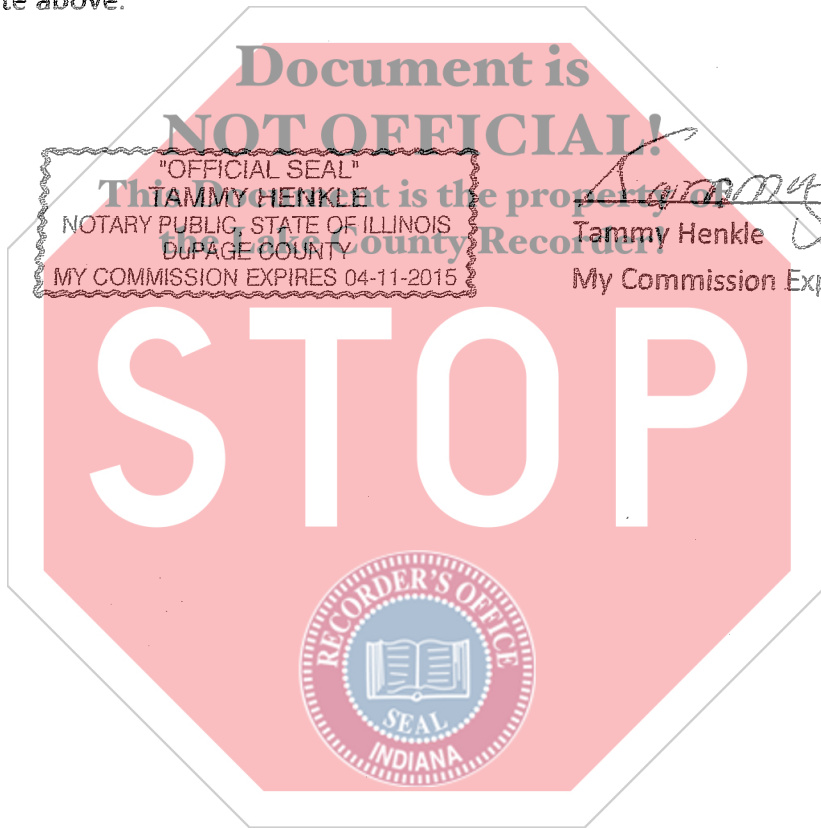
