PROVIDED, HOWEVER:

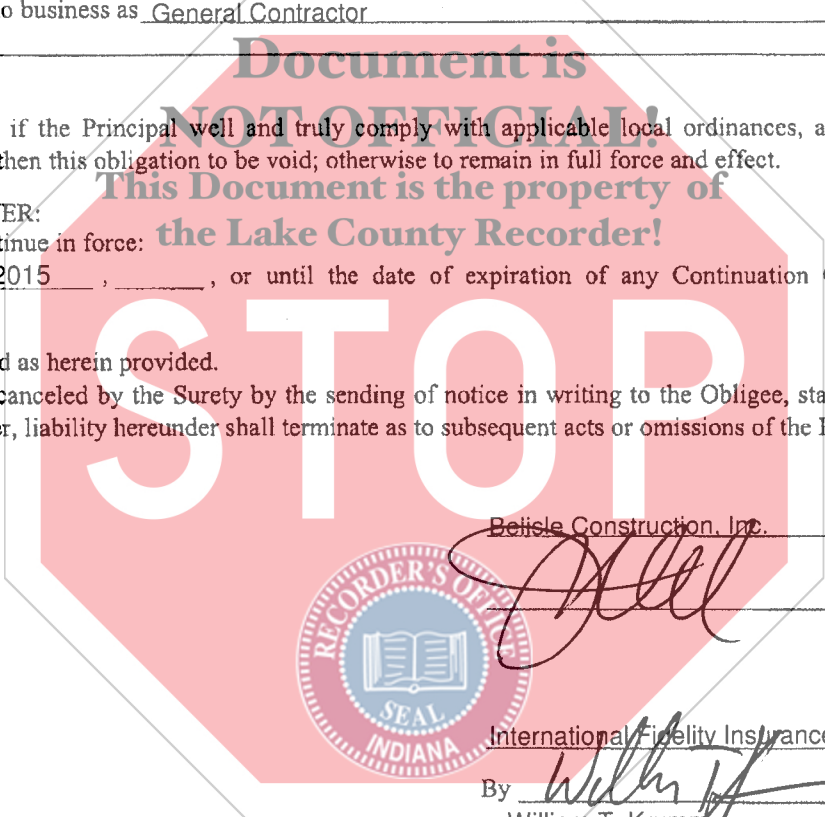
1. This bond shall continue in force:

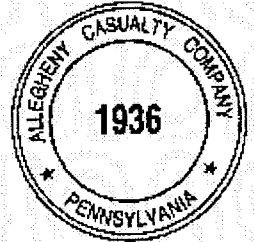

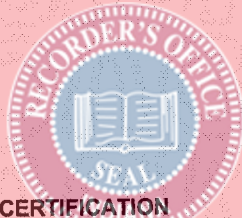
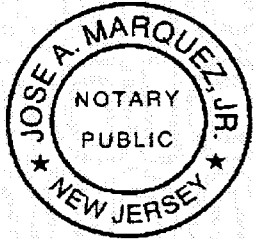
