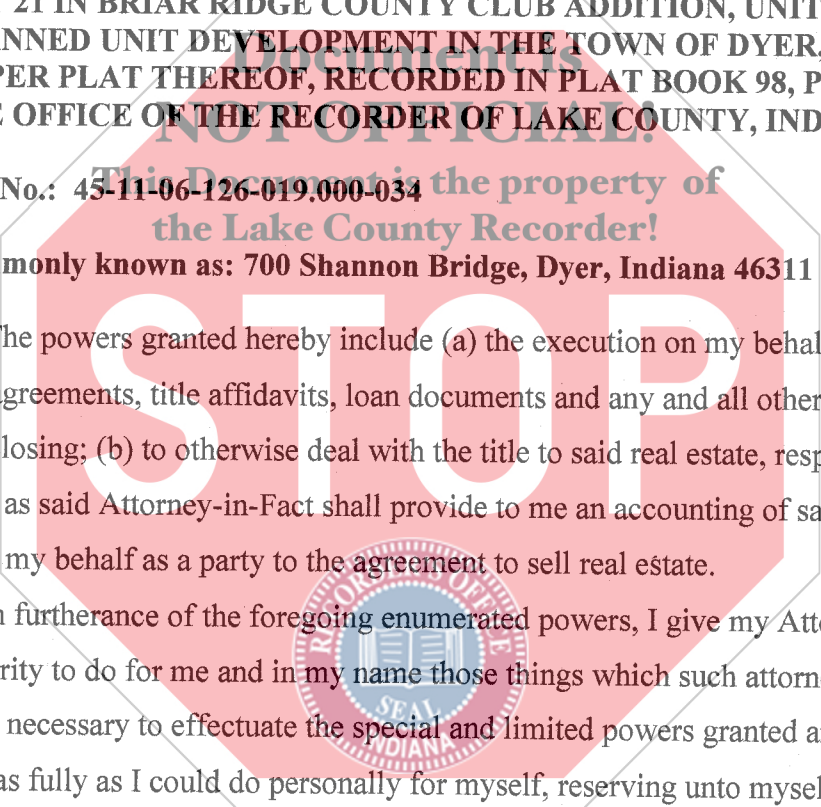

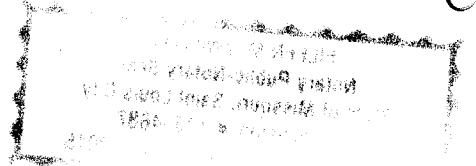
4. This power of attorney is durable and shall survive my subsequent disability or incapacity. (3)

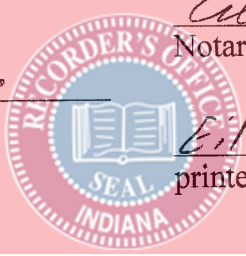
