WHEREAS, the Principal shall save and hold harmless the Oblige or any unknown third party from any loss, costs and damages, expenses or liability of any kind resulting from the issuance of said license or permit, and

WHEREAS, the said Principal will conform in all respects to the ordinances and building codes of the Oblige while performing Structural Iron Work work, and

WHEREAS, the effective date of this bond is January 1, 20 15.

NOW, THEREFORE, if the license shall be issued to the Principal who shall conform to the ordinances and codes, including all amendments thereto, of the Oblige, then this obligation shall be void, otherwise, the same shall remain in full force and effect until:

DEFINITE TERM ending December 31, 20 15 unless renewed by Continuation Certificate.

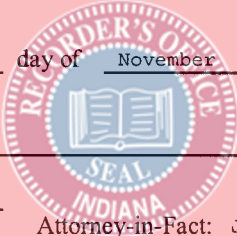
IT IS HEREBY AGREED AND UNDERSTOOD, that

- (2) The Surety reserves the right to cancel this bond by giving thirty (30) days written notice to the obligee and on the effective date of such thirty (30) day cancellation notice, the surety is discharged and relieved of any liability, being understood and agreed, however, that the said principal and said Surety will be liable for any loss accruing up to the effective date of said thirty (30) day cancellation notice, in no event, however, in excess of the penalty of the bond.

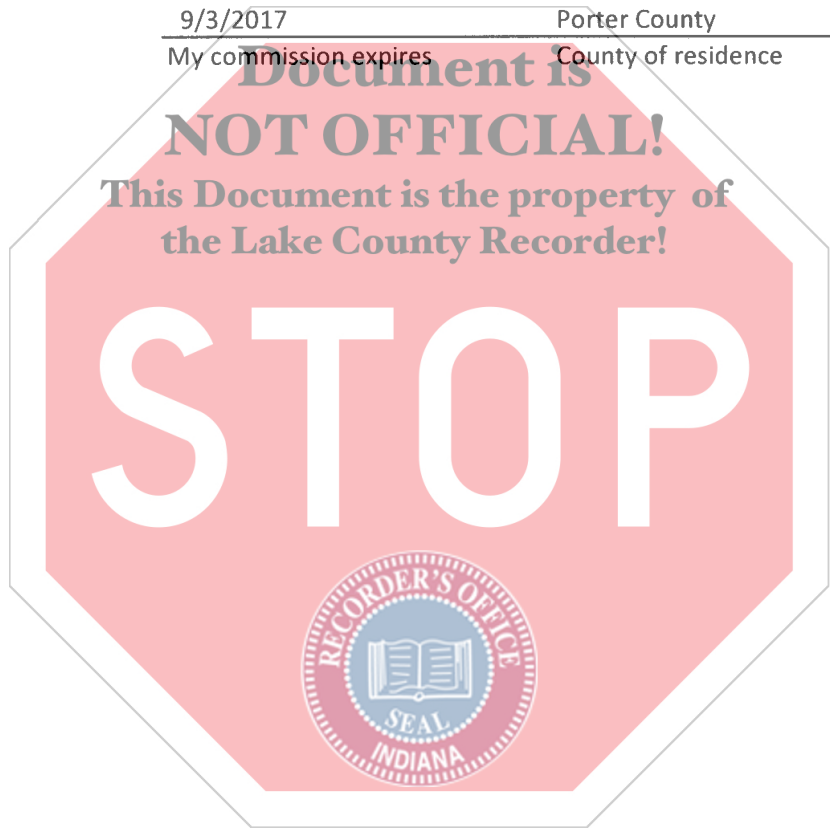

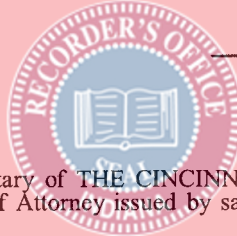
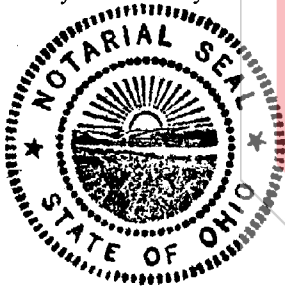
