This bond may be canceled by the Surety thirty (30) days after receipt by the Obligee of the Surety's written notice of cancellation.

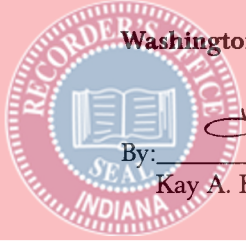
