
**AFFIDAVIT OF MISSING OR INCOMPLETE ASSIGNMENT**

I, **Ingrid Whitty**, the undersigned, being duly sworn, state as follows:

1. I am a/an **VICE PRESIDENT** of **EMC MORTGAGE LLC**. I make this affidavit based upon my review of our records concerning the loan, if any, described below and publicly available information.
2. A Security Instrument (the "Security Instrument") dated 12/16/1997 was executed by **PATRICIA A. ANDERSON AND MALLIE B. ANDERSON** in favor of **WMC MORTGAGE CORP.** and recorded on 12/23/1997 in the land records of LAKE County, State of IN in Book at Page and/or as Record/Instrument Number 97088404. The loan has subsequently been transferred.
3. I have conducted a search concerning this loan, including reviewing the following sources: Security Instrument; the collateral file for the loan; our business records specifying the contents of the collateral file; a title report; and/or information from the county LAKE concerning this loan.
4. After a review of Chase's records and a title report and information from LAKE County, IN, if any, I have not identified any assignments of the Security Instrument.
5. Based on the review described above, it appears there is a gap in the chain of assignments of the Security Instrument between **DEUTSCHE BANK NATIONAL TRUST COMPANY, AS INDENTURE TRUSTEE UNDER THE INDENTURE RELATING TO COLLATERALIZED ASSET-BACKED BONDS, SERIES 2000-2** and **EMC MORTGAGE LLC**. One or more assignments may be missing within this gap. To the extent we maintain records concerning this loan, those records do not reflect that the assignment(s) was/were completed.
