license or permit to the Principal, then this obligation shall be void; otherwise, to remain in full force and effect.

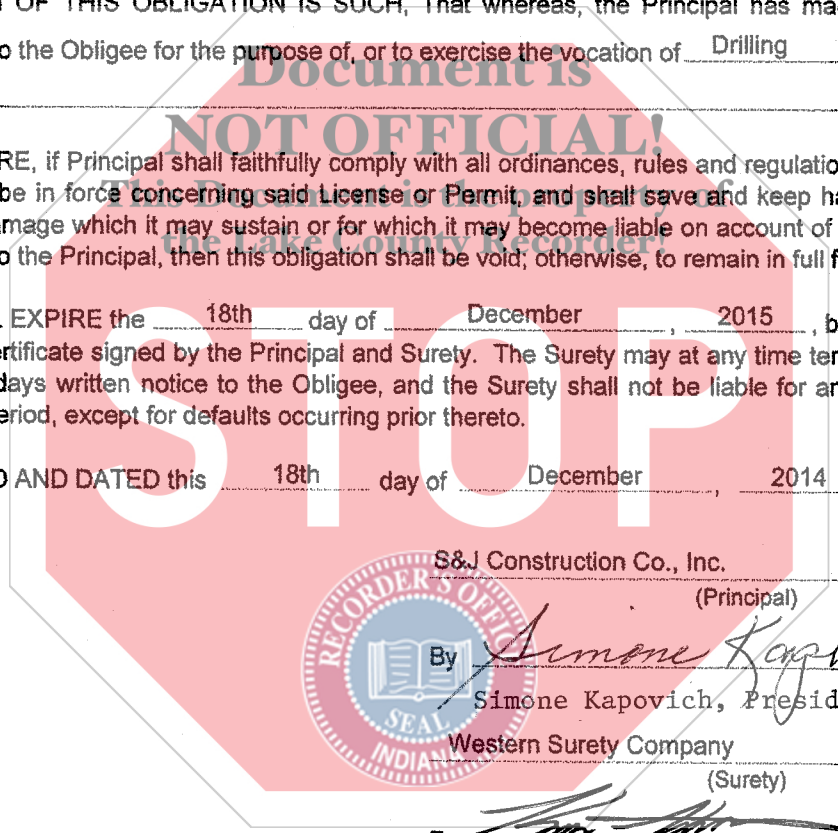
THIS BOND WILL EXPIRE the 18th day of December, 2015, but may be continued

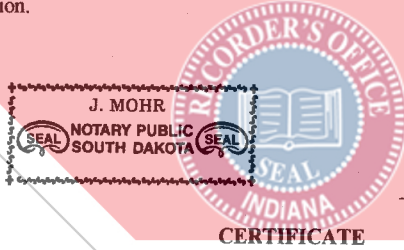

ADOPTED BY THE SHAREHOLDERS OF WESTERN SURETY COMPANY
