That he and the decedent were owners by the entireties of the following described real estate, to wit:

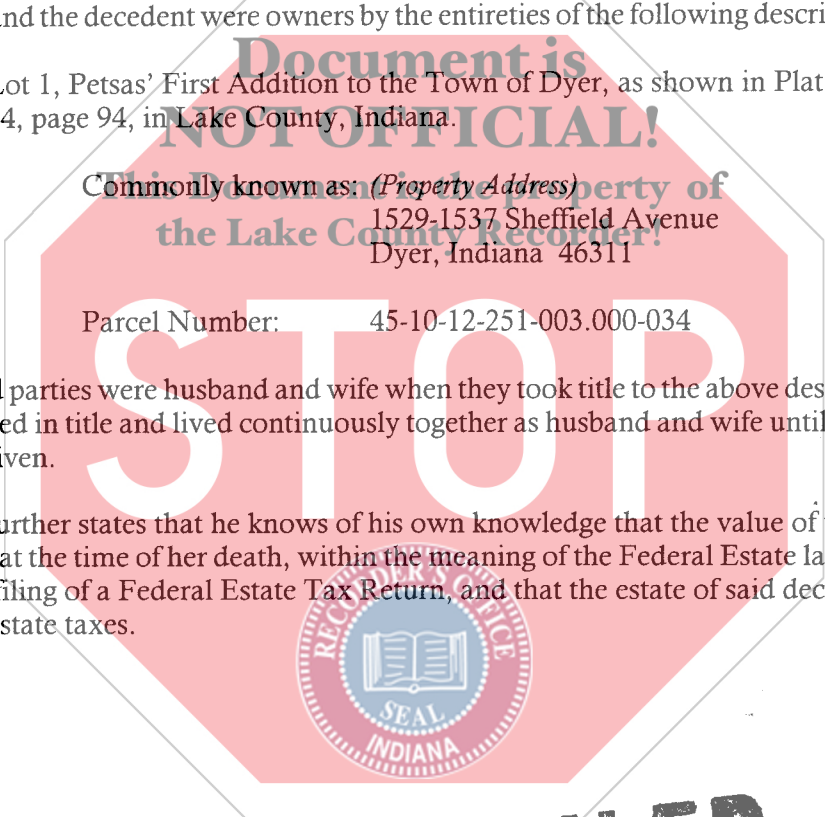



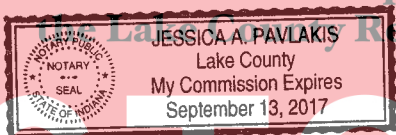
