Principal at any time by giving thirty (30) days written notice of such termination to the Board.

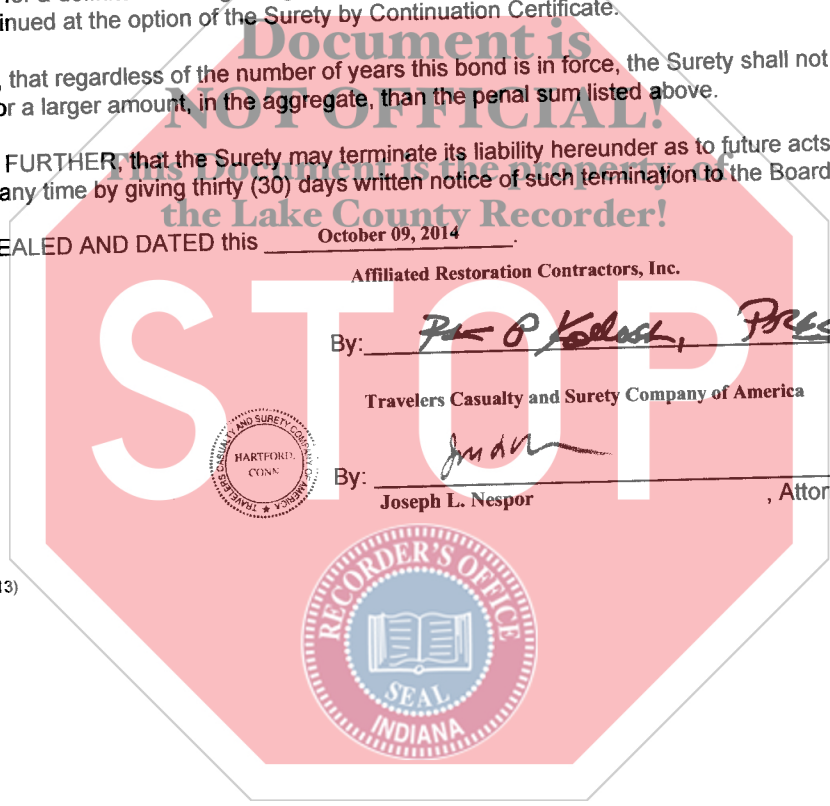

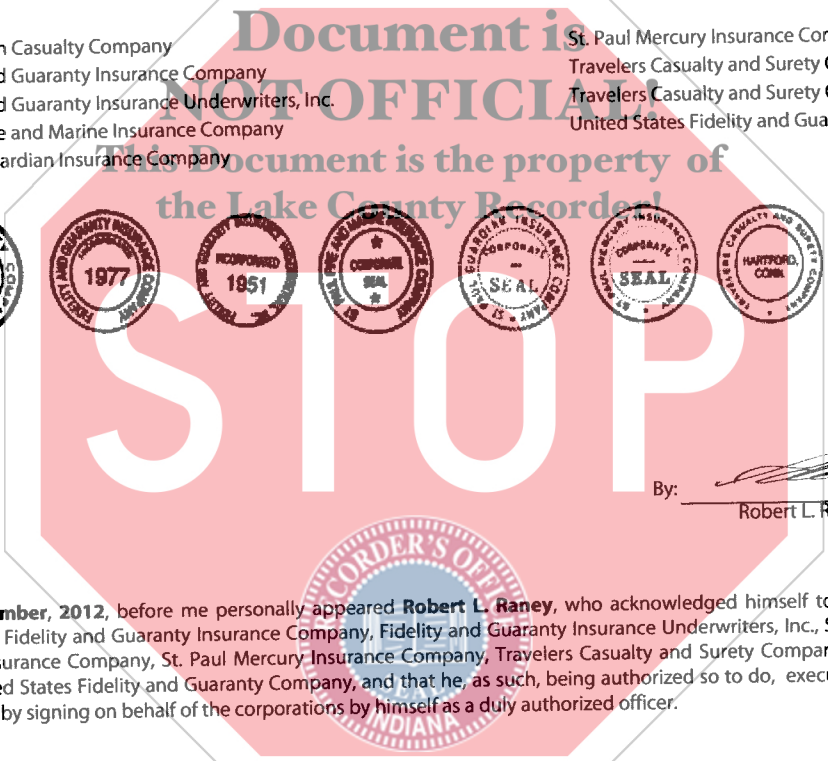
