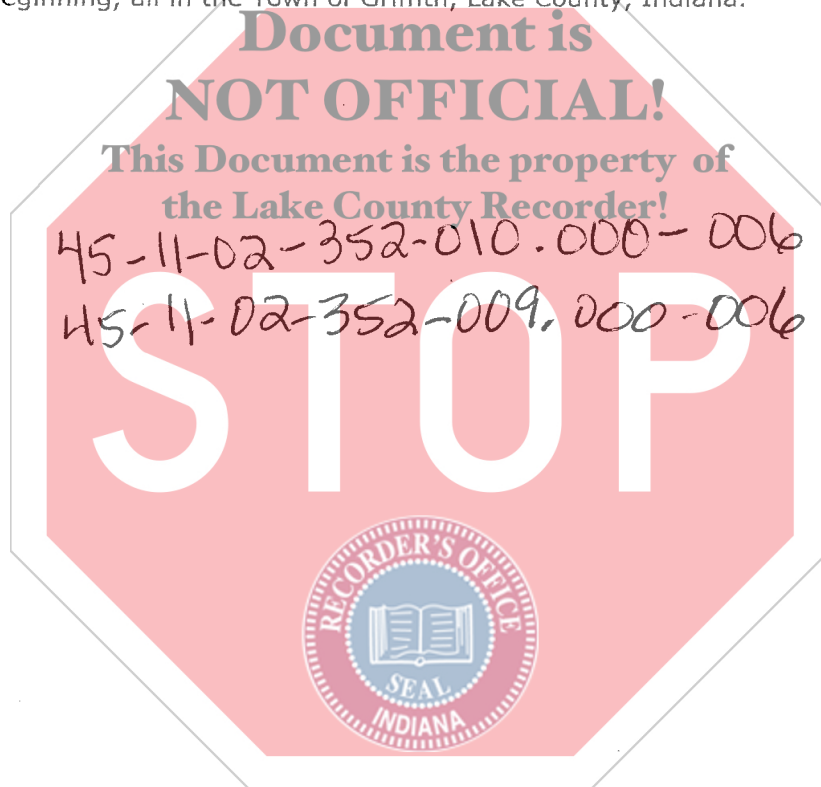

EXHIBIT A

A parcel of land lying in the Southwest 1/4 of the Southwest 1/4 of Section 2, Township 35 North, Range 9 West of the Second Principal Meridian, in Lake County, Indiana, more particularly described as follows: Commencing at a point 85 feet West and 30 feet North of the Southeast corner of the Southwest 1/4 of the Southwest 1/4 of the aforesaid Section, said point being in the North right of way line of Avenue "H"; thence West and parallel to the South line of said Section and along the North right of way line, a distance of 255 feet to a point; thence North and parallel to the East line of the aforesaid 1/4 1/4 Section, a distance of 180 feet to a point; thence East and parallel to the South line of said Section, a distance of 289 feet to a point in the West right of way line of Broad Street; thence South along the right of way line, a distance of 146 feet to a point; thence Southwesterly, a distance of 48.8 feet to the point of beginning, all in the Town of Griffith, Lake County, Indiana.
