


FRAUDULENT DOCUMENT AFFIDAVIT

Here and now comes the undersigned Affiant, of age of maturity, and of freewill to attest to the truth told below:

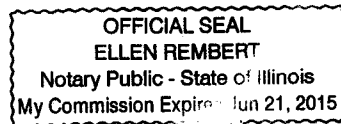
1. TRUST PROPERTY in legal description LOT 14, MARGENAU'S SUBDIVISION, HAMMOND, AS SHOWN IN PLAT BOOK 14, PAGE 35, IN LAKE COUNTY, INDIANA . PARCEL No. 45-06-12-301-007-000-023 Commonly Known as: 26 169<sup>th</sup> St, HAMMOND, IN 46324 . has been conveyed to the MOORISH SCIENCE TEMPLE OF AMERICA.
2. Sheik Scuefield Bey, has tax exemption and exclusionary status under 501(c1) and via number 52-1147644.
3. That said property is trust property of the Moorish Science Temple of America and is not subject to property taxes due to our classification or any other encumbrances.
4. Sheik Scuefield Bey, Classification is as follows: National Archive Record Group 147, Book 5-21, file 5-39, U. S. Department of Defense file 1-17, Unique Identifier 1237-7, Hierarchal Code R1.01.052.004, Federal Code 667 and Federal Code 463; Our authority: Cook County Recorder of Deeds, document 10105905, book 521, page 579 (recorded under the Torrens' system), United States Department of Justice BM:\$HR:WD:144-35-0.
5. That the Mortgage lien is the Color of title, having appearance of title, but No actual title or rights in Law. The LAKE COUNTY SHERIFF'S OFFICE, bill is therefore fraud pursuant to case law First National Bank of Montgomery vs. Jerome Daly and Anheuser-Busch Brewing Company V. Emma Mason, 44 Minn. 318, 46 N.W. 558.
6. That document 10105905, book 521, page 579 is the title of the vast estate of the Moorish Science Temple of America. 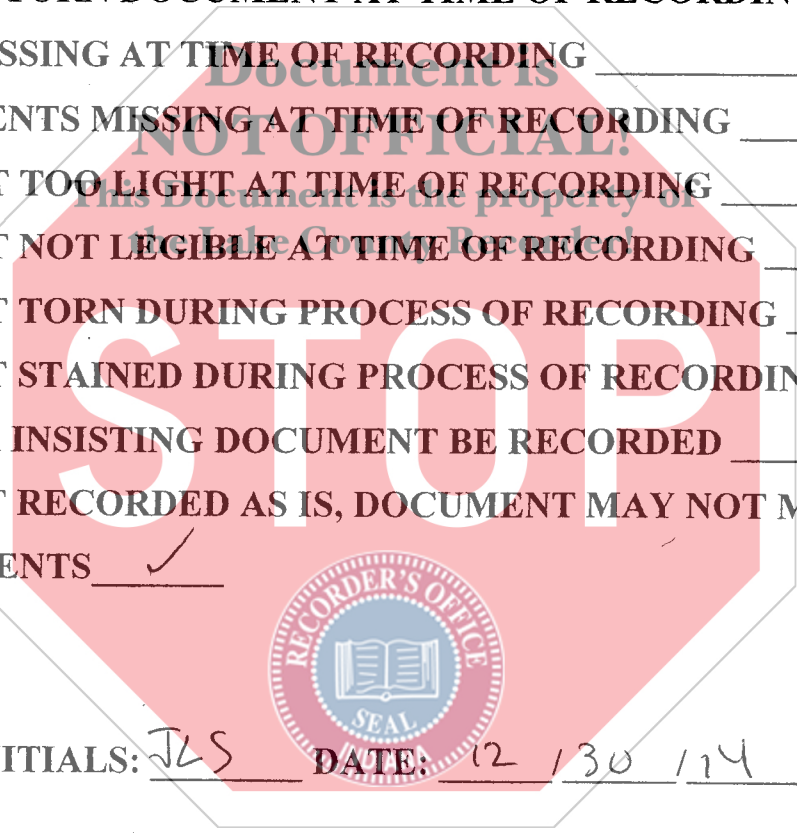
