SPECIAL WARRANTY DEED

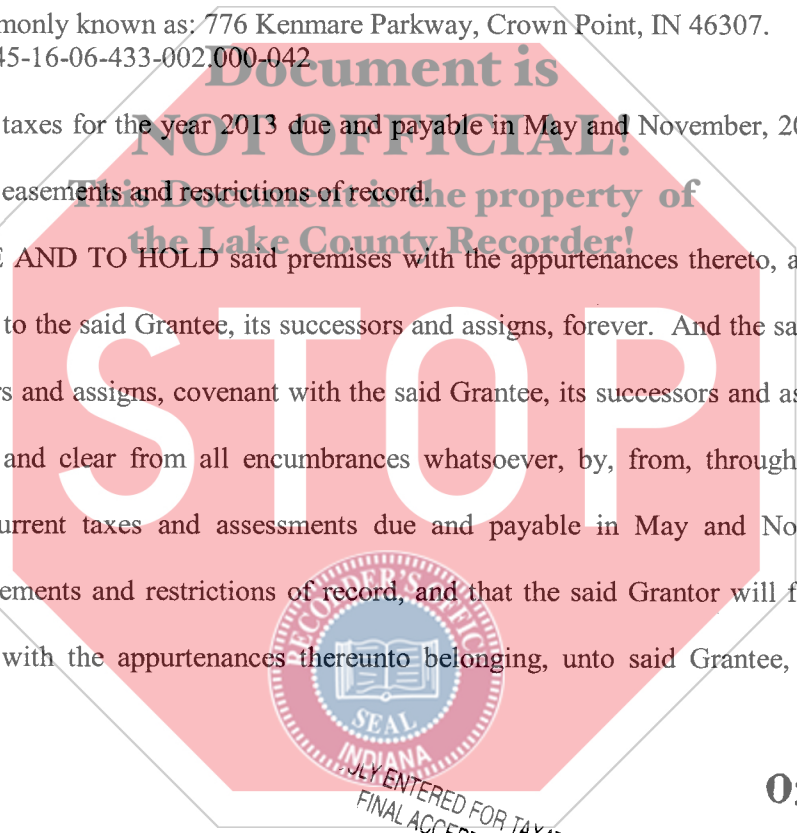

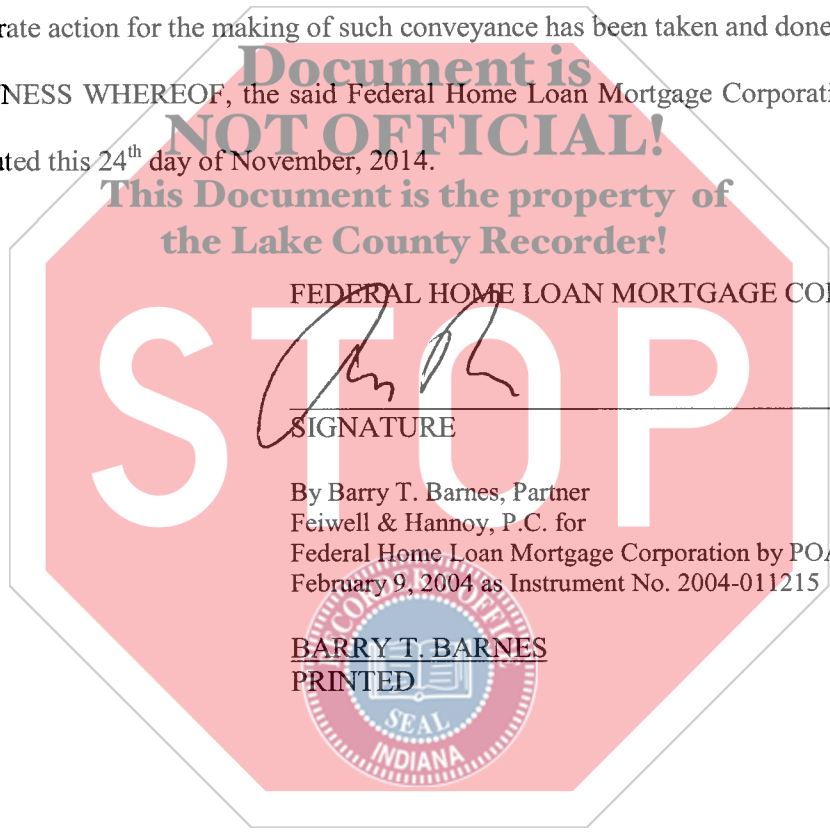

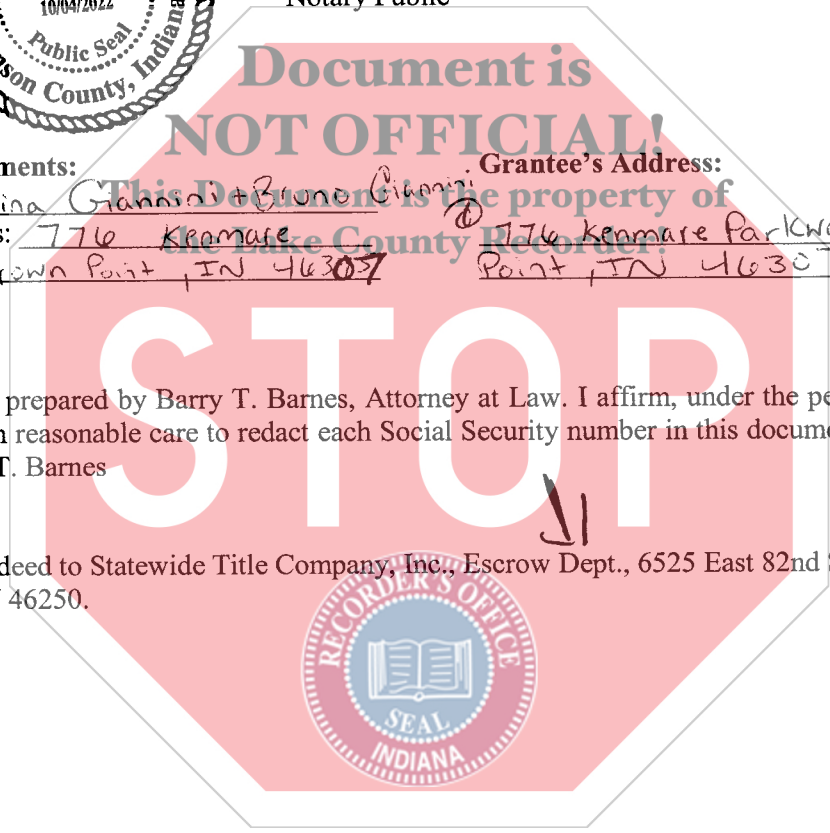
