LEGAL DESCRIPTION

Situate in Lake County, State of Indiana:

A part of the Southeast Quarter of the Northeast Quarter of the Southeast Quarter of Section 12, Township 36 North, Range 9 West of the Second Principal Meridian in the City of Gary, Calumet Township, Lake County, Indiana, described as beginning at the Southeast corner of said Southeast Quarter of the Northeast Quarter of the Southeast Quarter which is the centerline intersection of 19th Avenue with the centerline of Clark Street; thence West on the South line of said Southeast Quarter of the Northeast Quarter of the Southeast Quarter for a distance of 383 feet; thence North at right angles for a distance of 120 feet; thence North 45 degrees West for a distance of 215.32 feet; thence North 45 degrees East for a distance of 42.4 feet; thence North 45 degrees East for a distance of 244.0 feet; thence South 45 degrees East for a distance of 42.4 feet; thence North 45 degrees East for a distance of 60 feet; thence North 45 degrees West for a distance of 44 feet; thence North 0 degrees 23 minutes 32 seconds West on a line parallel to and 322 feet West of the East line of said Southeast Quarter of the Northeast Quarter of the Southeast Quarter for a distance of 173.04 feet to the North line of said Southeast Quarter of the Northeast Quarter of the Southeast Quarter; thence South 89 degrees 43 minutes 32 seconds East on said North line for a distance of 322 feet; thence south 0 degrees 23 minutes 32 seconds East on the East line of said Southeast Quarter of the Northeast Quarter of the Southeast Quarter for a distance of 659.50 feet to the place of beginning.
