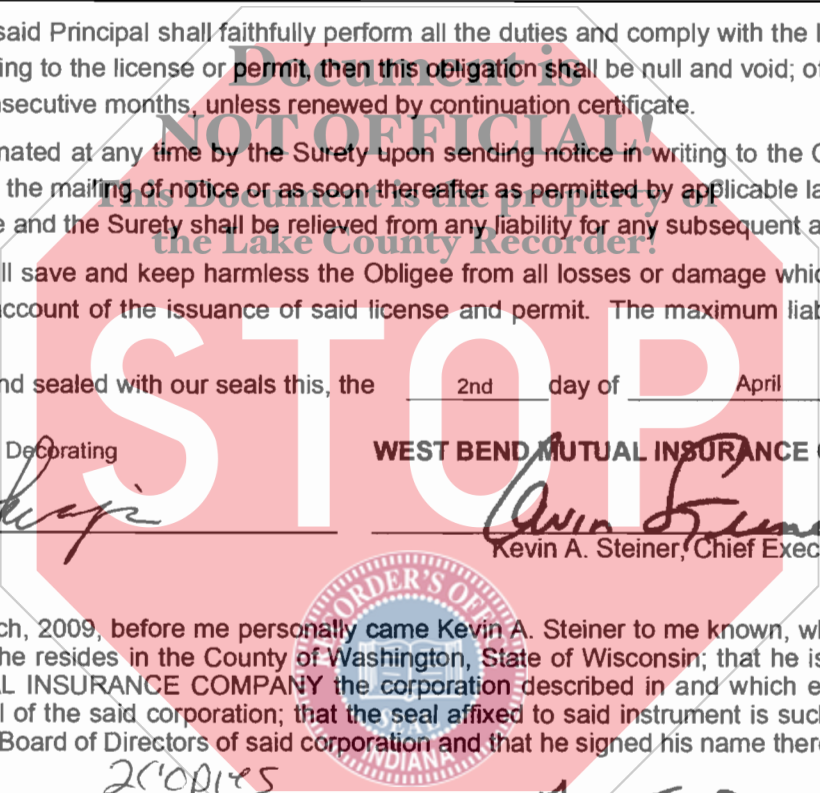



Power of Attorney


