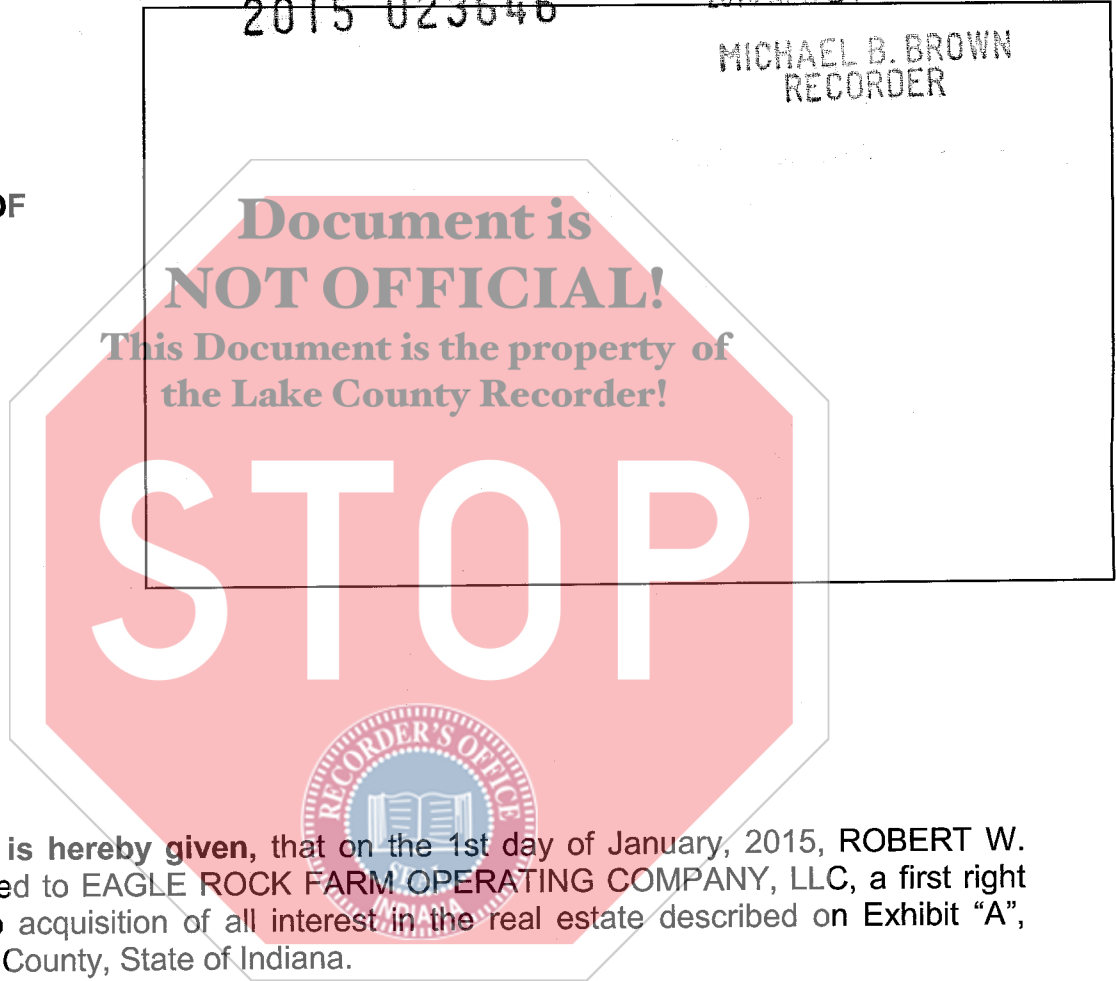

Part of the East Thirty (30) acres of the Northeast Quarter of Section 25, Township 33 North, Range 8 West of the Second Principal Meridian, in Eagle Creek Township, Lake County, Indiana, being more particularly described as follows:

Beginning at a point on the east line of said Section 25 which is 784.6 feet South of the Northeast corner of said Section 25, being the Northeast corner of a tract conveyed to Jerry C. and Susan J. Hayden in Instrument Number 2004-029699 in the Office of the Recorder of Lake County, Indiana; thence continuing South 00°00'00" East, along the East line of the Northeast corner of said Section 25, also being the East line of said "Hayden" tract, a distance of 182.53; thence South 89°00'00" West, a distance of 108.60 feet; thence North 40°15'02" West, a distance of 111.02 feet; thence North 02°03'17" West, a distance of 97.86 feet, to a point on the North line of said "Hayden" tract; thence North 90°00'00" East, along the north line of said "Hayden" tract, being perpendicular to the aforesaid East line of said Section 25, a distance of 183.84 feet, to the Point of Beginning; Containing 0.690 Acres, more or less, all in Eagle Creek Township, Lake County, Indiana.
