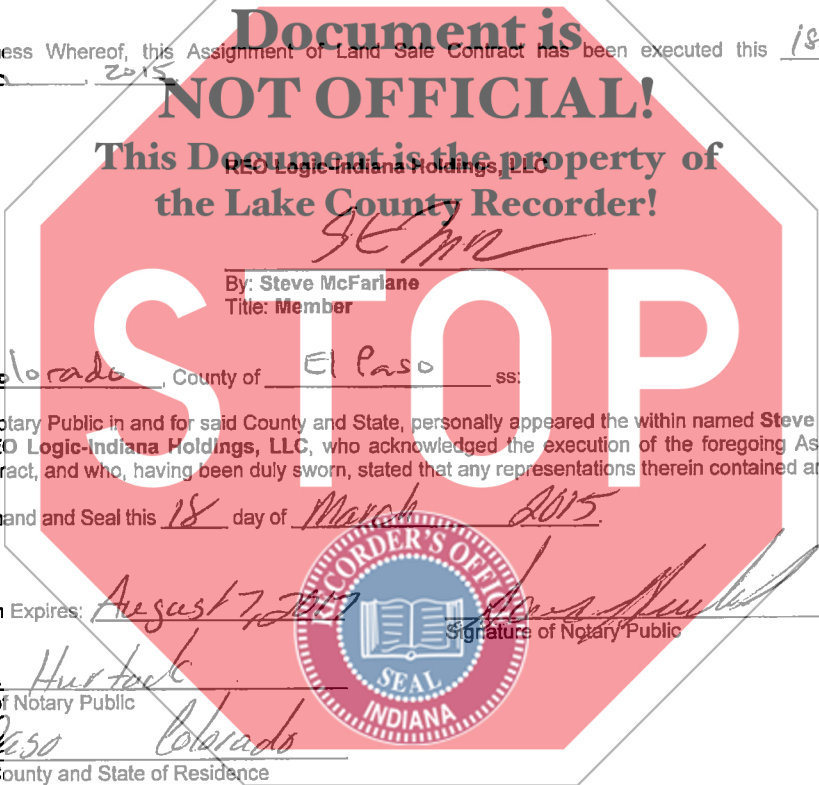
ASSIGNMENT OF LAND SALE CONTRACT
