ORDINANCE TO ADD PROPERTIES TO THE DOWNTOWN HISTORIC DISTRICT IN THE CITY OF CROWN POINT, INDIANA

WHEREAS, the City of Crown Point previously has established the Downtown Historic District within the City of Crown Point pursuant to the authority and procedures granted by Chapter 156 of the Crown Point Code of Ordinances; and

WHEREAS, in the process to establish the Downtown Historic District it was recommended by the Crown Point Historic Preservation Commission that the contiguous property shown on Exhibit A to this Ordinance located on "West Street" is an architecturally significant building within the City of Crown Point and is recommended to be included in the Downtown Historic District.

NOW, THEREFORE, BE IT ORDAINED by the Common Council that the Downtown Historic District is hereby expanded to include those properties shown on Exhibit A to this ordinance, and that said properties are part of the Downtown Historic District.

Be it finally ordained that this Ordinance shall be deemed effective and published as of the date of its adoption and approval by the Common Council, and the Clerk-Treasurer of Crown Point shall file and retain a copy of this Ordinance in that Office as a supplement to the City of Sown Point Code of Ordinances.
