The powers enumerated in the foregoing paragraphs are designed as exemplification of the full and complete general powers granted herein and are not intended to be any limitation thereof. I hereby ratify all that my said attorney-in-fact shall lawfully do by virtue of this Power of Attorney. Any lawful act done by my attorney-in-fact shall be binding upon myself, my heirs, and legal and
