- A. The new Maturity Date will be: FEBRUARY 01, 2045.
- B. The modified principal balance of my Note will include amounts and arrearages that will be past due as of the Modification Effective Date (including unpaid and deferred interest, fees, escrow advances and other costs, but excluding unpaid late charges, collectively, "Unpaid Amounts") less any amounts paid to the Lender/Mortgagee but not previously credited to my Loan. The new principal balance of my Note will be \$101,179.03 (the "New Principal Balance"). I understand that by agreeing to add the Unpaid Amounts to the outstanding principal balance, the added Unpaid Amounts accrue interest based on the interest rate in effect under this Agreement. I also understand that this means interest will now accrue on the unpaid Interest that is added to the outstanding principal balance, which would not happen without this Agreement.
- C. Interest at the rate of 3.625% will begin to accrue on the New Principal Balance as of FEBRUARY 01, 2015 and the first new monthly payment on the New Principal Balance will be due on MARCH 01, 2015. My payment schedule for the modified loan is as follows:
