PERSONAL REPRESENTATIVE'S DEED

THIS INDENTURE WITNESSETH, That Maegan A. Karasinski, as Personal Representative of the Unsupervised Estate of Gene Francis Karasinski, a/k/a Gene F. Karasinski, deceased, Cause No. 45CO1-1503-EU-000067 pending in the Lake Circuit Court, Lake County, Indiana, pursuant to the Personal Representative's power and authority under Indiana law, hereby distributes to Jason T. Walker and Amanda L. Rocha-Arana, as tenants in common, an undivided one-half (1/2) interest to each, in the following legally described real estate in Lake County, in the State of Indiana:
