Parcel 1: Part of the West 1/2 of the Southeast 1/4 of Section 5, Township 34 North, Range 8 West of the 2nd P.M., described as: Commencing at a point 231.5 feet North of the Northwest corner of Lot "K", in Railroad Addition to Crown Point, thence North 75 feet, thence due East to the center of the road leading from Crown Point to Merrillville, thence Southerly along the center of said road to a point due East of the place of beginning, thence due West to the place of beginning, in the City of Crown Point, Lake County, Indiana.
