That YVONNE L. SCHUCK is the owner in fee simple of the following described real estate located in Lake County, Indiana, more particularly described as follows:

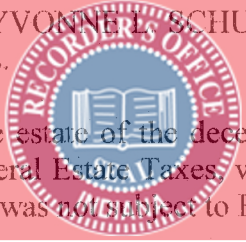
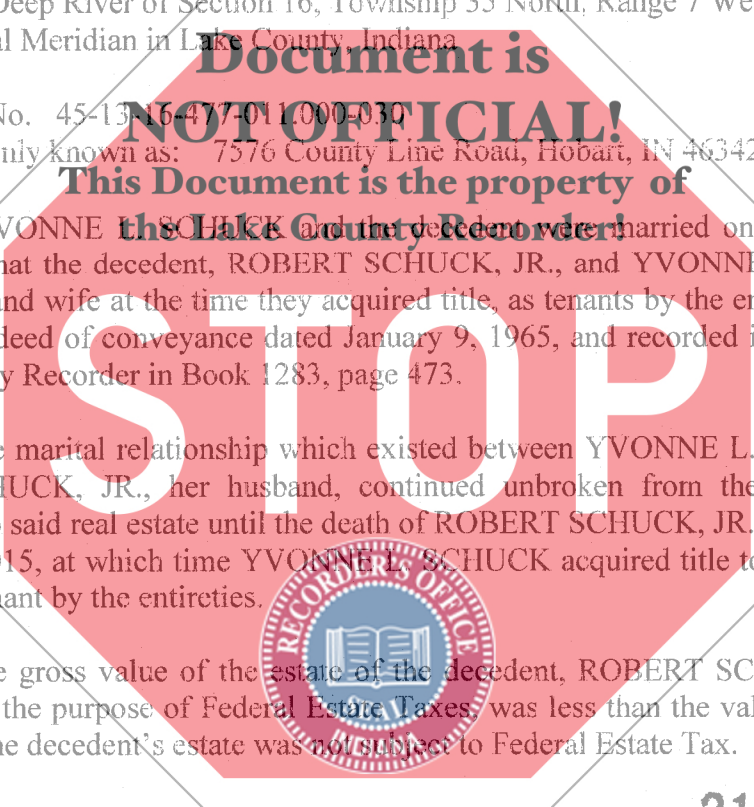
