William J Summers, 304 Fairbanks Pl, Munster, Indiana 46321, a Son, born November 08, 1963. (25%)

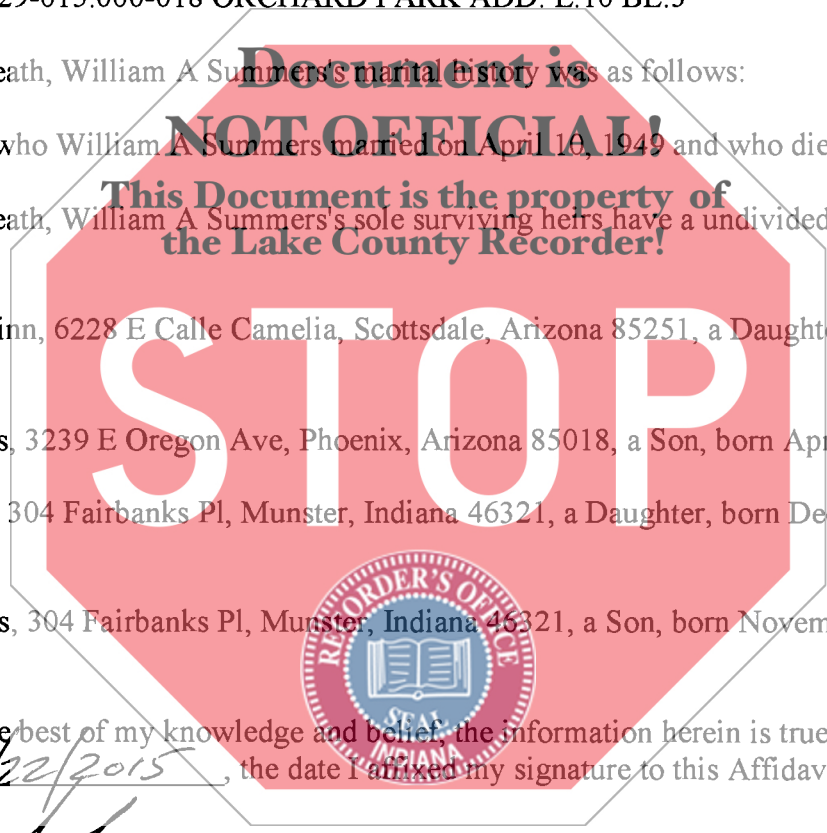
