KNOW ALL MEN BY THESE PRESENTS:

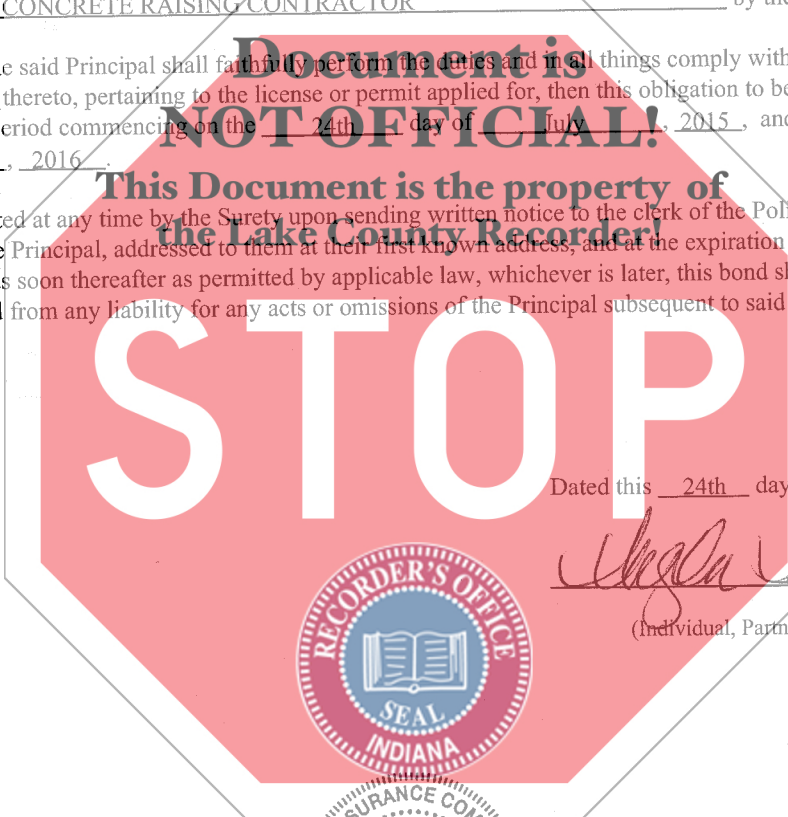
That we, CORRECT CONCRETE RAISING LLC
