

Any inspection of the Property shall be entirely for Lender's benefit and Mortgagee will in no way rely on Lender's inspection.

Property Condition, Alterations and Inspection. Mortgagor will keep the Property in good condition and make all repairs that are necessary. Mortgagor shall not commit or allow any waste, impairment, or deterioration of the Property. Mortgagor agrees that the nature of the occupancy and use will not substantially change without Lenders' prior written consent. Mortgagor will not permit any change in any license, restrictive covenant or easement without Lender's prior written consent. Authority to Perform. If Mortgagor fails to perform any duty or any of the covenants contained in this Security Instrument, Lender may, without notice, perform or cause them to be performed. 


