
That we, SBA Network Services, LLC, 8051 Congress Ave, Boca Raton, FL 33487-1307

Any and all bonds provided the bond penalty does not exceed Twenty Five Million Dollars (\$25,000,000.00).

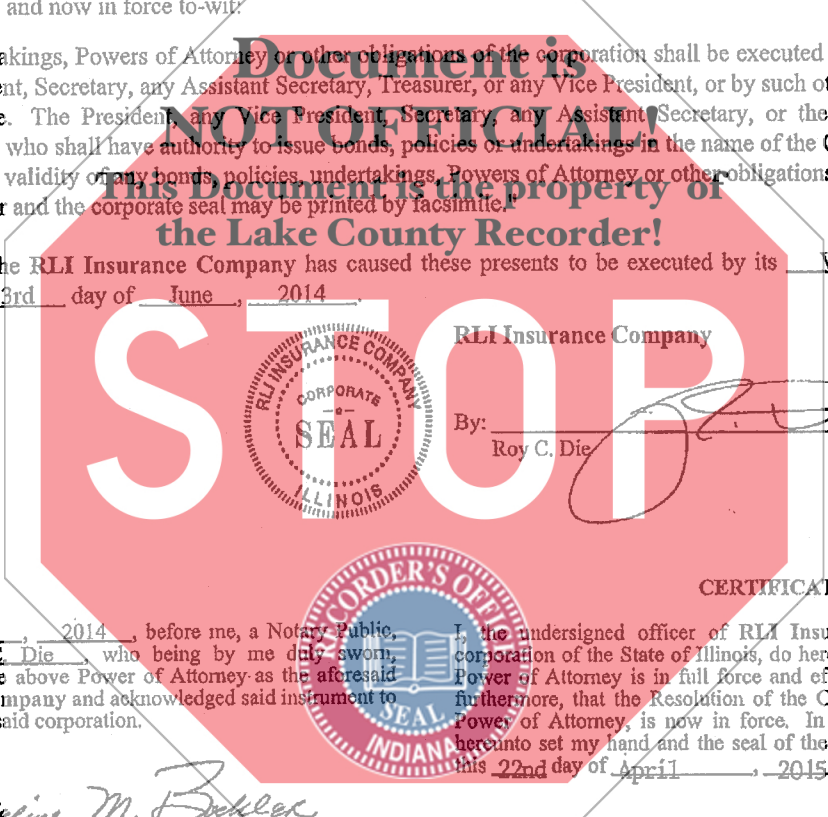
