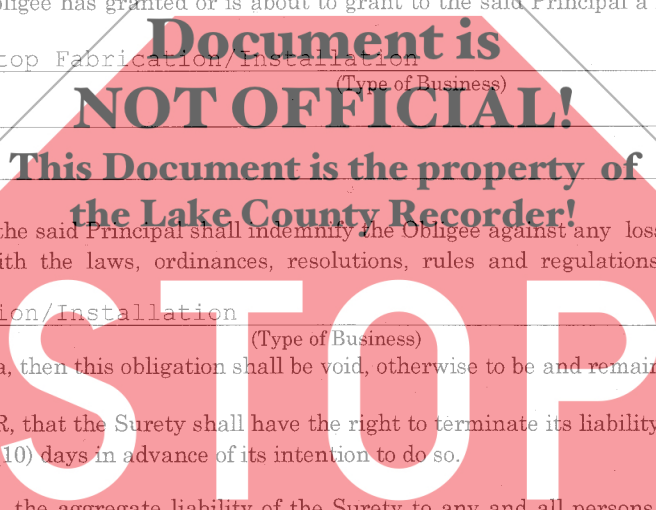
KNOW ALL PERSONS BY THESE PRESENTS, that we, The Countertop Factory Midwest, Inc.
