Further proceedings held on Petition to Revoke Probation First Amended. Pursuant to the plea agreement, the defendant admits to the allegations in the Petition to Revoke Probation First Amended. The Court finds that the defendant has violated the rules of probation.

The Court revokes the defendant's probation. The defendant is sentenced to eighteen (18) months in the Indiana Department of Correction. Said sentence is to be served in Lake County Community Corrections and consecutively to the sentence imposed in Cause #45G03-1503-F6600943.

The defendant is to receive credit for one hundred thirteen (113) days spent in confinement as a result of this charge, plus one hundred thirteen (113) days of good time credit as provided by law for a total of 226 days credit.

The defendant is remanded to the Lake County Sheriff for transportation to Lake County Community Corrections. The restitution owed, in the amount of Four Hundred Ten Dollars and Ninety-Six Cents (\$410.96) is entered as a judgment against the defendant in favor of the victim. The defendant is discharged unsatisfactorily from probation. (Christine L. Jones reporting.)
