fully vested with all the title, estate, rights, powers, authorities, duties and obligations of its, them or their predecessors in trust.

The conveyance is made upon the express understanding and condition that Marvin A. Miller and Darlene M. Miller, and as Trustees, their Successor and Successors in Trust shall not incur any personal liability or be subjected to any claim, judgment or decree for anything they or their agents or attorneys may do or omit to do in or about the real estate or under the provisions of this deed or the Trust Agreement or any amendment thereto, or for injury to person or property happening in or about the real estate, any and all such liability being hereby expressly waived and released. DeGraff and Maureen Miller, all as Trustee, the entire legal and equitable title in fee sample, in and to all of the real estate above described.
