hereinafter called the Obligee, in the amount of Five Thousand Dollars & No/100***** (\$5,000.00*****)

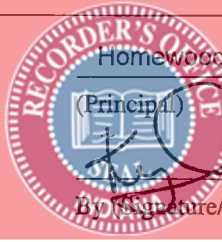

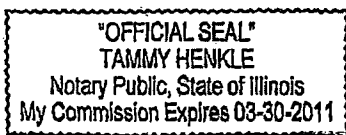
