

Limited Power of Attorney

This Limited Power of Attorney is dated as of May 29, 2015, by the following NRZ entities:

U.S. BANK NATIONAL ASSOCIATION, NOT IN ITS INDIVIDUAL CAPACITY, BUT SOLELY AS TRUSTEE FOR THE NRZ PASS-THROUGH TRUST I, ITS SUCCESSORS AND ASSIGNS;

U.S. BANK NATIONAL ASSOCIATION, NOT IN ITS INDIVIDUAL CAPACITY, BUT SOLELY AS TRUSTEE FOR THE NRZ PASS-THROUGH TRUST II, ITS SUCCESSORS AND ASSIGNS;

U.S. BANK NATIONAL ASSOCIATION, NOT IN ITS INDIVIDUAL CAPACITY, BUT SOLELY AS TRUSTEE FOR THE NRZ PASS-THROUGH TRUST IV, ITS SUCCESSORS AND ASSIGNS;

U.S. BANK NATIONAL ASSOCIATION, NOT IN ITS INDIVIDUAL CAPACITY, BUT SOLELY AS TRUSTEE FOR THE NRZ PASS-THROUGH TRUST V, ITS SUCCESSORS AND ASSIGNS; and

U.S. BANK NATIONAL ASSOCIATION, NOT IN ITS INDIVIDUAL CAPACITY, BUT SOLELY AS TRUSTEE FOR THE NRZ INVENTORY TRUST, ITS SUCCESSORS AND ASSIGNS

each having an office at c/o Fortress Investment Group, 1345 Avenue of the Americas, 46th Floor, New York, New York 10105 (individually, an "NRZ Entity" and collectively, the "NRZ Entities"), appointing as attorney-in-fact, Pretium Mortgage Credit Partners I Loan Acquisition, LP, having an office at 120 S. 6th Street, Suite 2100, Minneapolis, MN 55402 ("Pretium")

KNOW ALL MEN BY THESE PRESENTS, that each of the NRZ Entities, hereby constitute and appoint Pretium, as each such NRZ Entity's true and lawful Attorney-in-Fact, in such NRZ Entity's name, place and stead and for each such NRZ Entity's benefit, in connection with all mortgage loans and REO properties (the "Assets") acquired by Pretium which are subject to that Mortgage Loan Purchase Agreement between NRZ Mortgage Holdings LLC and Pretium Mortgage Credit Partners I Loan Acquisition, LP dated as of March 27, 2015 (the "Agreement"), for the purpose of performing all acts and executing all documents in the name of the applicable NRZ Entity as may be reasonably necessary and appropriate to effectuate any of the following enumerated circumstances.

Pretium is authorized to act as attorney-in-fact in the following enumerated circumstances:

Each NRZ Entity hereby appoints Pretium as its attorney-in-fact, to exercise at any time all or any of the following powers: to execute on behalf of the applicable NRZ Entity any assignments, endorsements, deeds, documents or other instruments necessary to assign, convey, or otherwise transfer its interest in any of the Assets.

The undersigned gives said Attorney-in-Fact full power and authority to execute such instruments and to do and perform all and every act and thing necessary and proper to carry into effect the power or powers granted by or under this Limited Power of Attorney, each

subject to the terms and conditions set forth in the Agreement as fully as the undersigned might or could do, and hereby does ratify and confirm to all that said Attorney-in-Fact shall lawfully do or cause to be done by authority hereof.

If Pretium receives any notice of suit, litigation or proceeding in the name of an NRZ Entity during the term of this Limited Power of Attorney, then Pretium shall promptly forward a copy of same to the NRZ Entity.

By exercising its powers granted hereunder, Pretium Mortgage Credit Partners I Loan Acquisition, LP hereby agrees to indemnify, defend, and hold U.S. Bank National Association, as Trustee, and their respective directors, officers, employees and agents harmless from and against any and all liabilities, obligations, losses, damages, penalties, actions, judgments, suits, costs, expenses or disbursements of any kind or nature whatsoever incurred by reason or result of the exercise by Pretium Mortgage Credit Partners I Loan Acquisition, LP of the powers specifically granted to it hereunder. The foregoing indemnity shall survive the termination of this Limited Power of Attorney or the earlier resignation or removal of U.S. Bank National Association, as Trustee under the related agreements between U.S. Bank National Association, as Trustee and the NRZ Entities.


It is expressly understood and agreed by the parties that (a) this Power of Attorney is executed and delivered by U.S. Bank National Association, not individually or personally, but solely as Trustee of the Trusts, in the exercise of the powers and authority conferred and vested in it, pursuant to the applicable trust agreement, (b) any representation, warranty, covenant, undertakings and agreements herein made on the part of the Trusts is made and intended not as personal representations, warranties, covenants undertakings and agreements by U.S. Bank National Association but is made and intended for the purpose for binding only the Trusts, (c) nothing herein contained shall be construed as creating any liability on U.S. Bank National Association, individually or personally, to perform any covenant either expressed or implied contained herein, all such liability, if any, being expressly waived by the parties hereto and by any person claiming by, through or under the parties hereto, and (d) under no circumstances shall U.S. Bank National Association be personally liable for the payment of any indebtedness or expenses of the Trusts or be liable for the breach or failure of any obligation, representation, warranty or covenant made or undertaken by the Trusts under this Power of Attorney or any other related documents or any documents executed under authority hereof.

This Limited Power of Attorney shall terminate six (6) months from the date hereof.

Third parties without actual notice may rely upon the exercise of the power granted under this Limited Power of Attorney; and may be satisfied that this Limited Power of Attorney shall continue in full force and effect and has not been revoked unless an instrument of revocation has been made in writing by the undersigned or said termination date has passed.

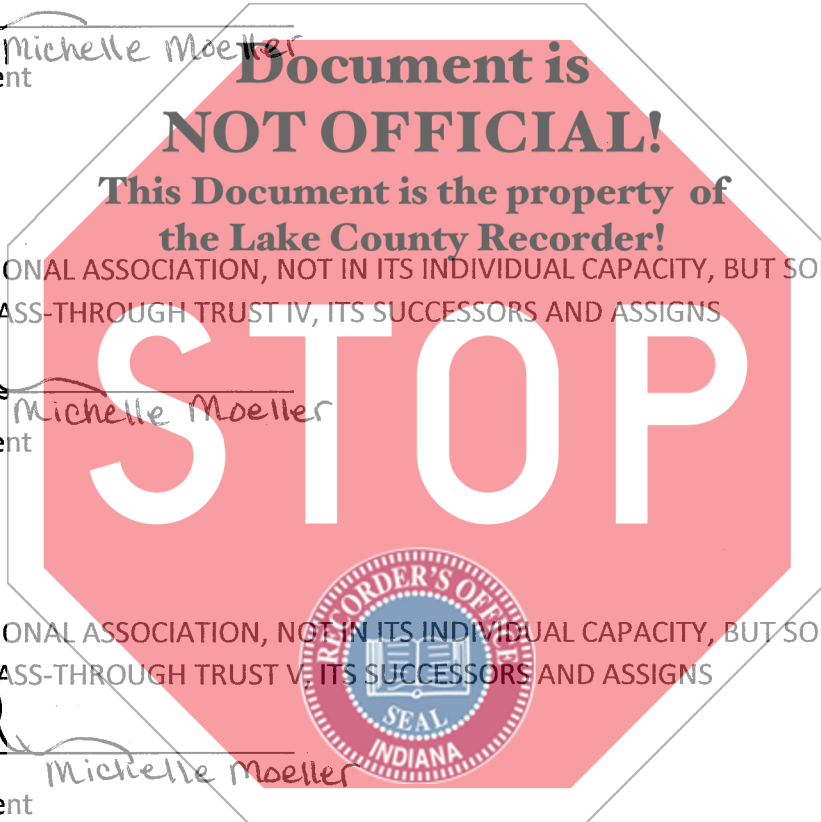




