KNOW ALL BY THESE PRESENTS:

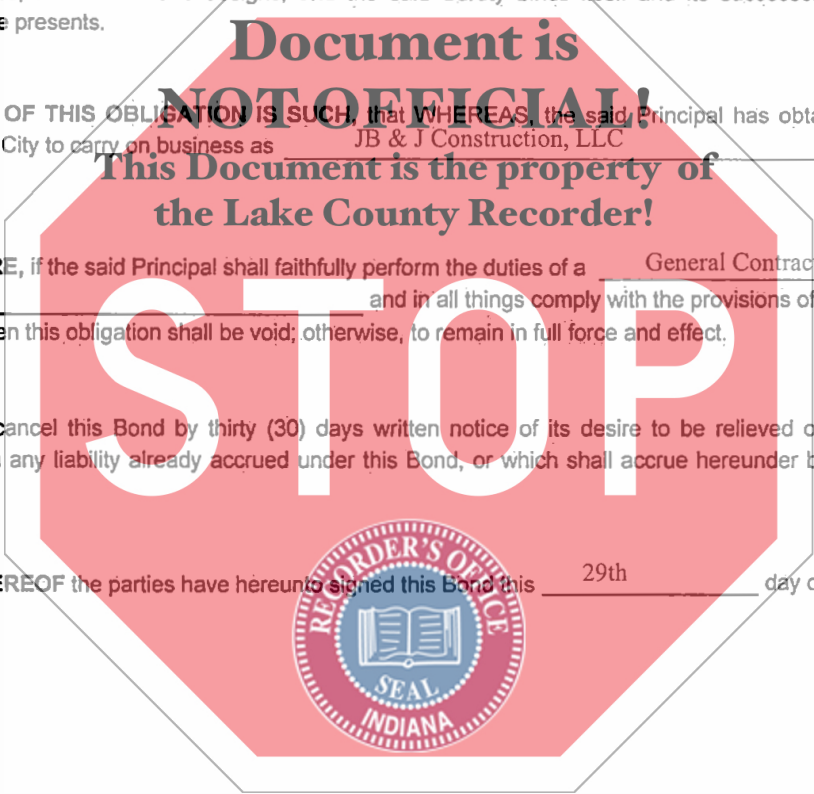
That we, JB & J Construction, LLC

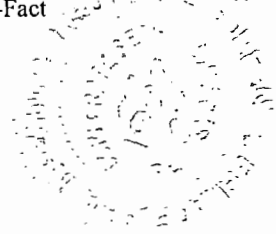

Power of Attorney

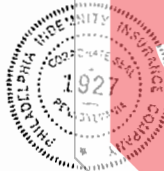

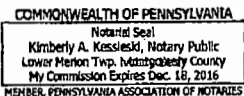
