DEED IN TRUST

THIS INDENTURE WITNESSETH, that Carey L. Pruitt, Jr. and Darla J. Pruitt, husband and wife ("Grantor") of Lake County, in the State of Indiana CONVEYS and WARRANTS to The Carey L. Pruitt, Jr. and Darla J. Pruitt Revocable Living Trust Agreement dated September 29, 2015, ("Grantee") in consideration of Ten Dollars (\$10) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the following described real estate in Lake County, in the State of Indiana:

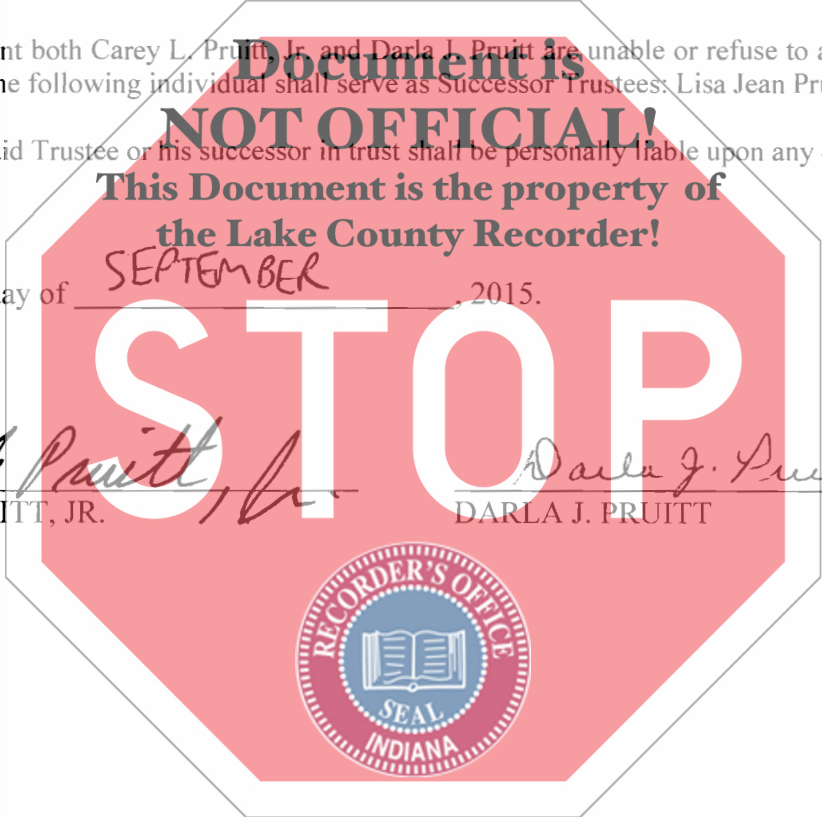
