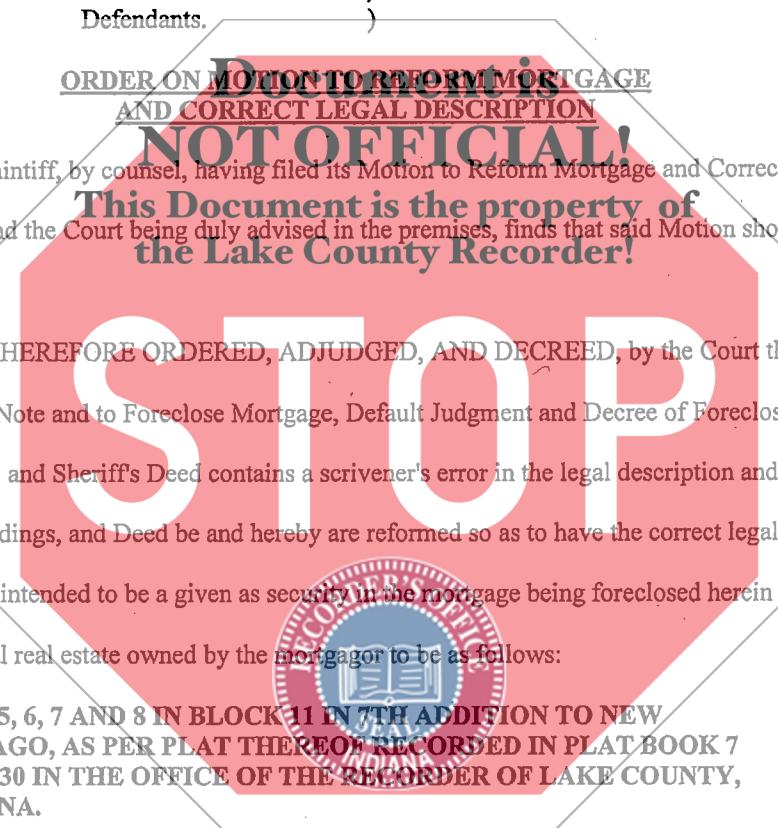
**ORDER ON MOTION TO REFORM MORTGAGE
