It is therefore ORDERED by the Court that the Motion to Avoid a Judicial Lien of Capital One Bank (USA), N.A. is hereby GRANTED.

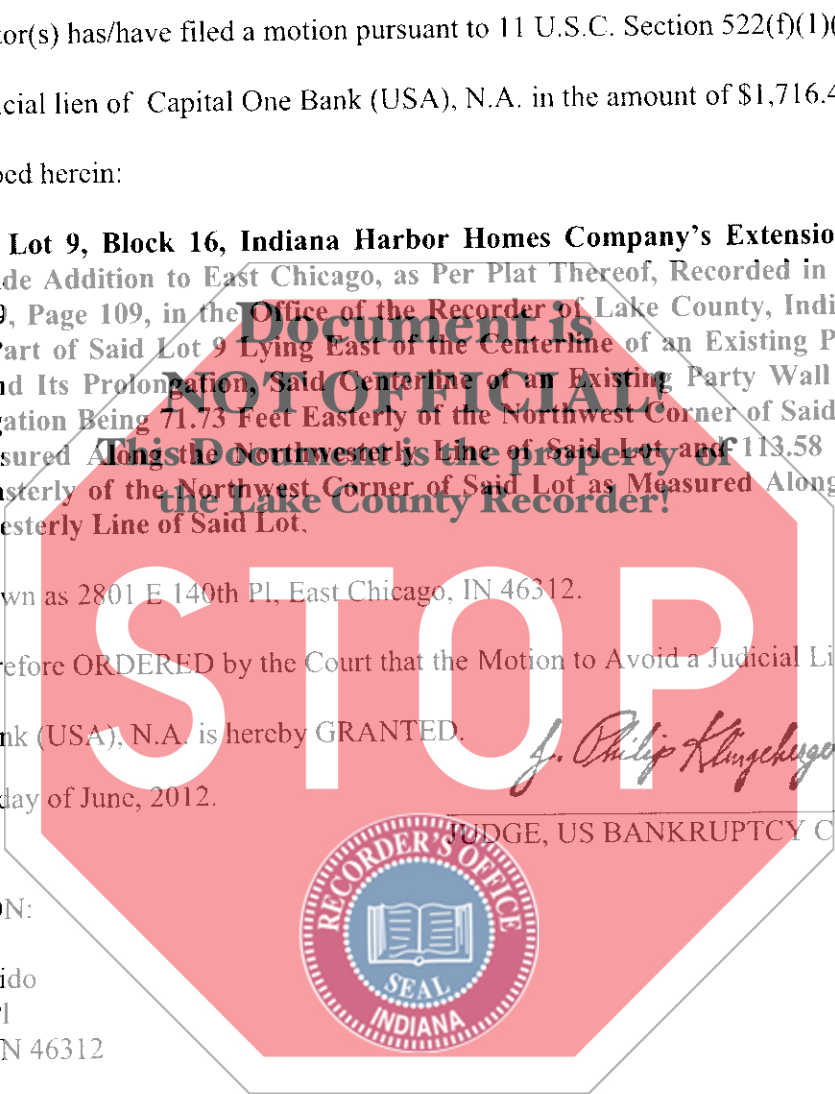
