It is therefore ORDERED by the Court that the Motion to Avoid a Judicial Lien of Midland Funding LLC is hereby GRANTED.

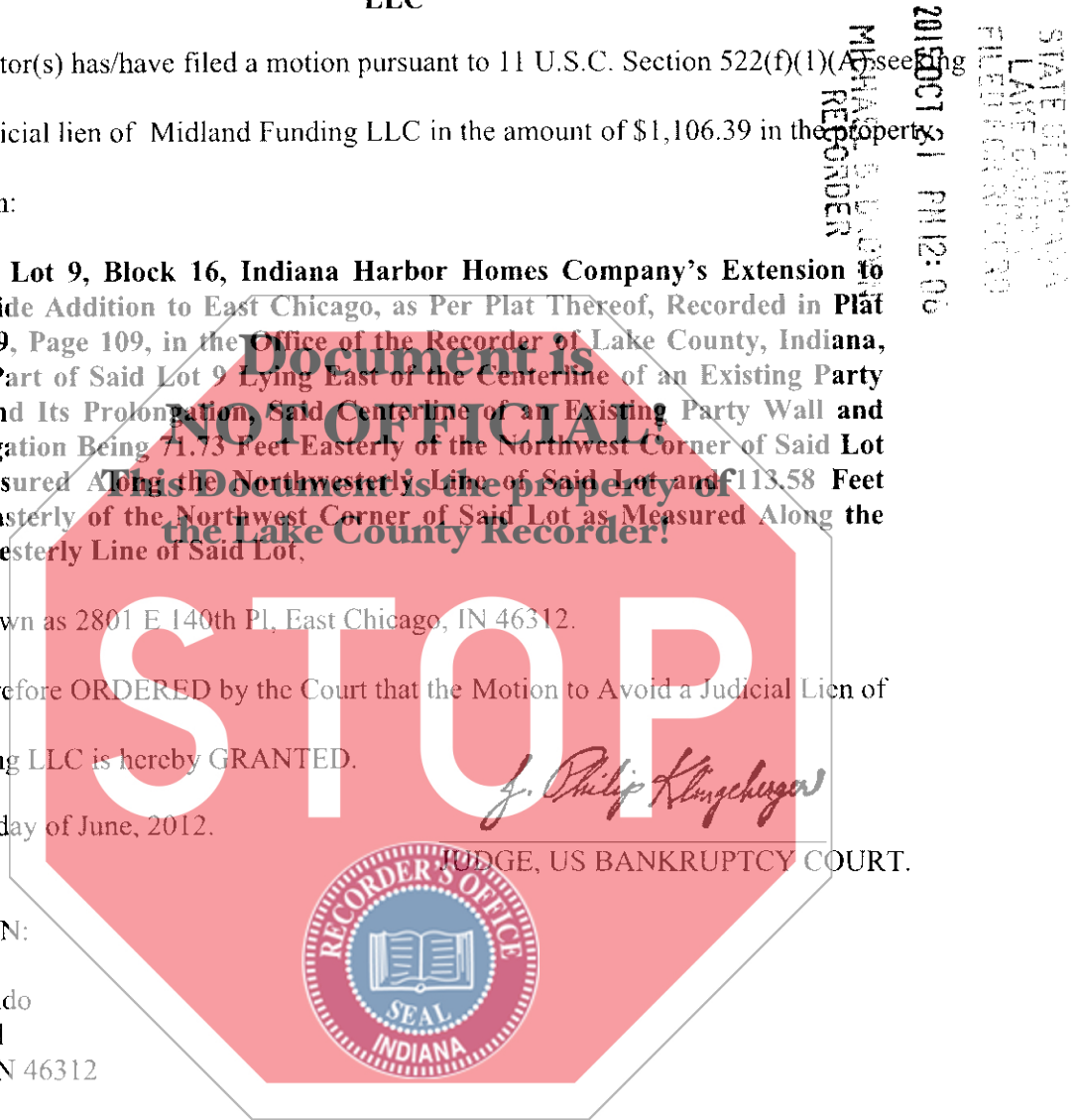
