KNOW ALL MEN BY THESE PRESENTS:

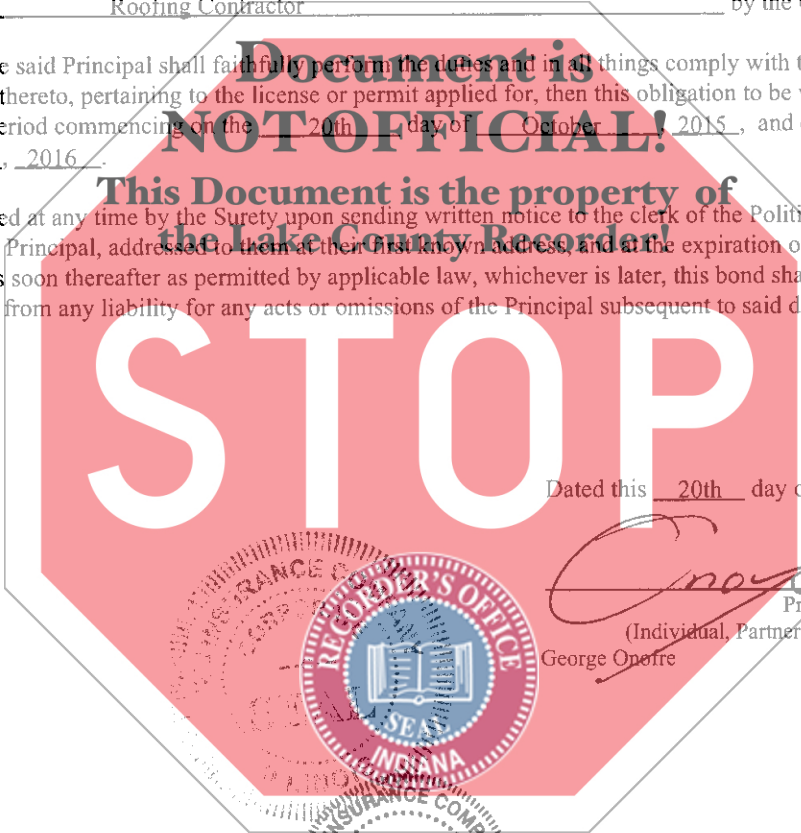
That we, Pioneer Renovations, Inc.

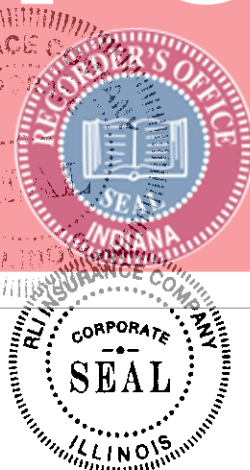
