**Section 1. Existence.**

The Trustee's delivery of a copy of this paragraph, certified by the Trustee as a true copy is sufficient (without requiring examination of the remainder of the Trust Agreement document) to release and discharge any such person or legal entity from any

irregularity, invalidity or impropriety in any provision of the Trust Agreement or on the part of the Trustee arising out of any such transaction or application of proceeds.

*Section 4. Trustee's Title.*

The Trustee is vested with absolute title to all Trust assets, both as to principal and income therefrom, subject only to the execution of the Trust.

*Section 5. Trustee's Powers.*

In order to meet the obligations of the Trust Agreement, the Trustee has the powers, granted in the Trust Agreement and as set forth in Exhibit "A" attached, and has also all statutory powers allowed to trustees under applicable Federal and Indiana statutes, unless expressly excluded or amended as set forth in the Exhibit "A" attached. The Trustee shall exercise these powers solely with respect to transactions involving the custody and investment of the Trust assets and proceeds therefrom. Those powers do not extend to assets and transactions which lie outside the scope of this Trust Agreement

*Section 6. Successor Trustee.*

The Successor Trustee, upon his or her acceptance of administration of said Trust without order of court, shall succeed to all obligations and powers, including discretionary powers, granted to the Trustee. Each successor to the Successor Trustee has identical powers and obligations of the Successor Trustee.

The Affiant herein began serving as Co-Trustee on April 16, 1996, with Jimmy D. Hooseline. The Affiant has been serving as sole Trustee upon Jimmy D. Hooseline's death on July 15, 2013, and continues to act in her capacity as Trustee of the Trust.
