MARIAN S. HOOSELINE, being duly sworn upon oath, deposes and says:

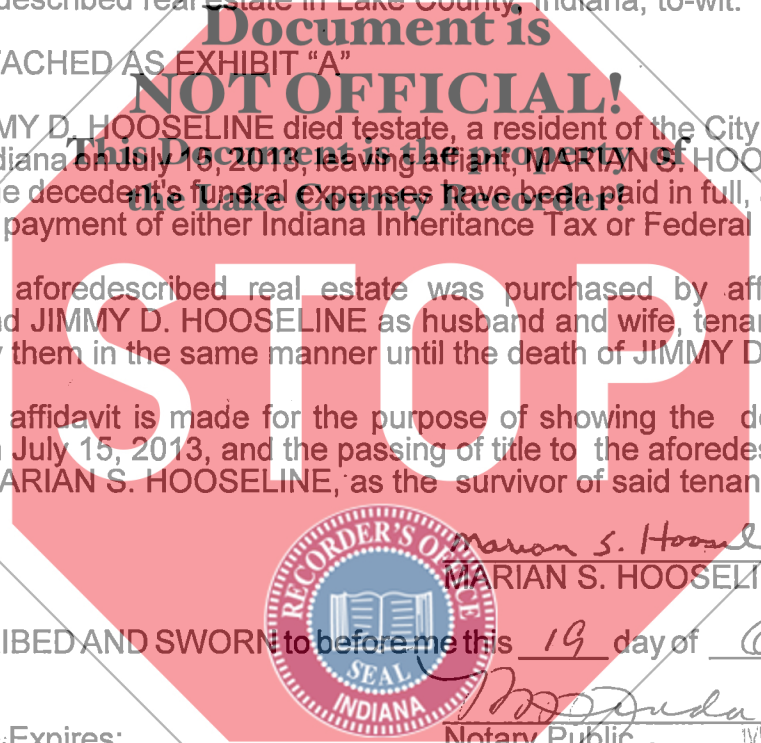
