**AFFIDAVIT CONFIRMING TRANSFER OF BENEFICIAL INTEREST;
AND APPOINTMENT OF SUCCESSOR TRUSTEES**

The undersigned, being duly sworn, state that on or about December 28, 1976, Jimmy D. Hooseline and Marian S. Hooseline, as Trustees, created and executed a document entitled "Hooseline Land Trust No. One". Jimmy D. Hooseline was initially named as Trustee and 100% beneficial owner.

2. Thereafter, until his death, Jimmy D. Hooseline served as Trustee of the Hooseline Land Trust No. One.

3. The Trust owns an interest in certain properties, including:

a. 50% undivided interest in an undeveloped parcel (sometimes referred to as the "Corning Property") at 9490 Mississippi Street, Merrillville, Indiana, tax ID 45-12-34-226-010.000-030, held as tenant in common with Lake County Trust 2945, as to the remaining 50% undivided interest;

b. 1135 Sunnyslope Drive, Crown Point, Indiana, parcel 64-11-10-151-005.000-028;

c. several parcels referred to as the "Lowell Farm" currently containing 188 acres +/- and described in said trust agreement prior to the sale of 12 acres.

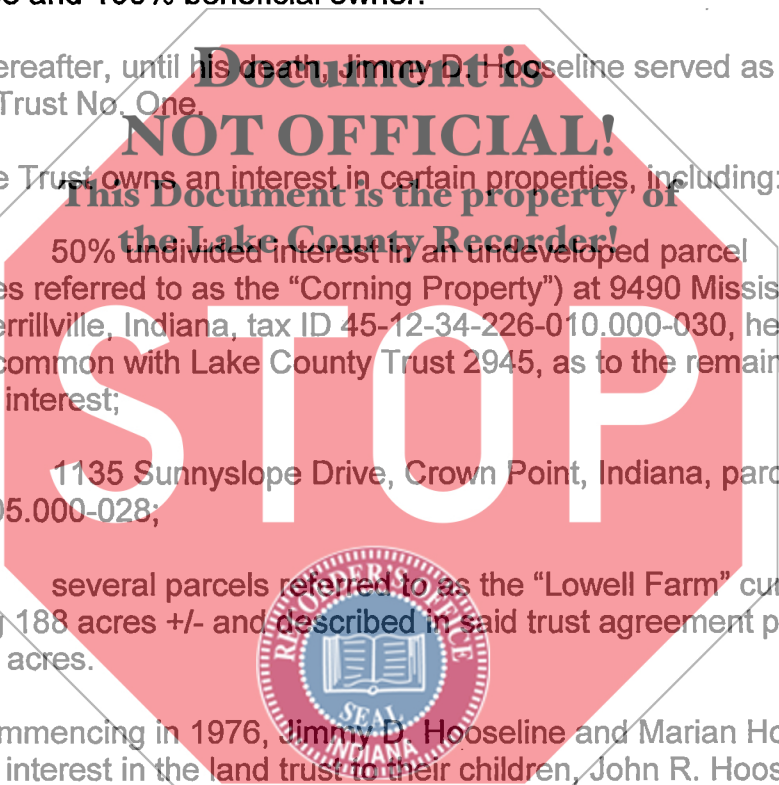
4. Commencing in 1976, Jimmy D. Hooseline and Marian Hooseline made fractional gifts of interest in the land trust to their children, John R. Hooseline and Mary Kay Hooseline n/k/a Collins. All gifts were itemized in writing prepared by Jimmy D. Hooseline as to date of gift and value of gift, and such written itemization kept to confirm the fact that no gift tax was due.

5. When the gifts totaling 100% of the beneficial interests in the trust were completed to John R. Hooseline and Mary Kay Hooseline n/k/a Collins, the said John R. Hooseline and Mary Kay Hooseline n/k/a Collins became beneficiaries of the trust, each as to an undivided 50% interest.

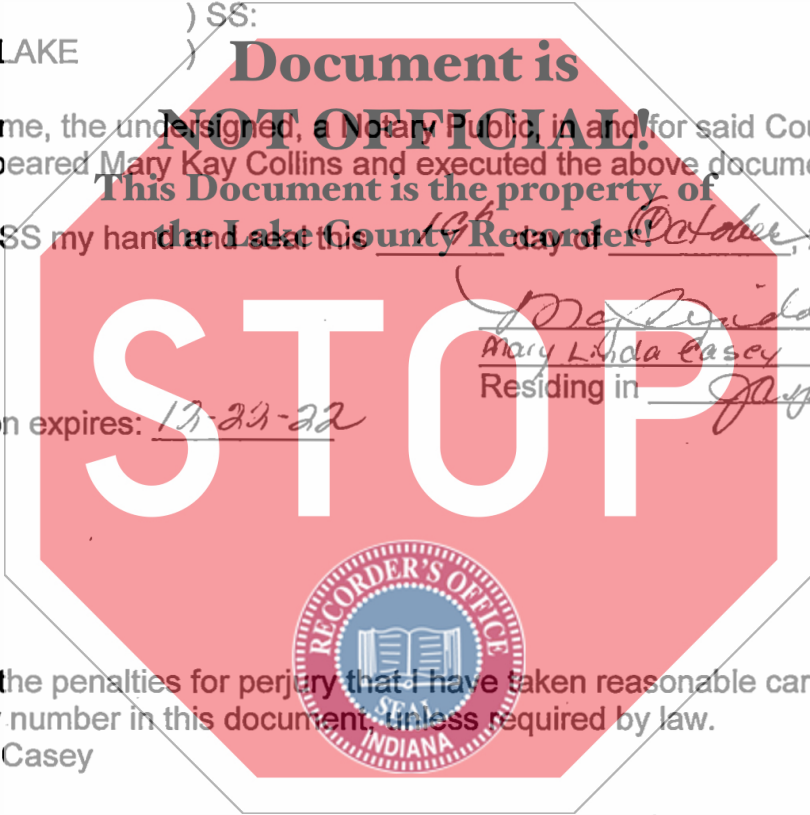
