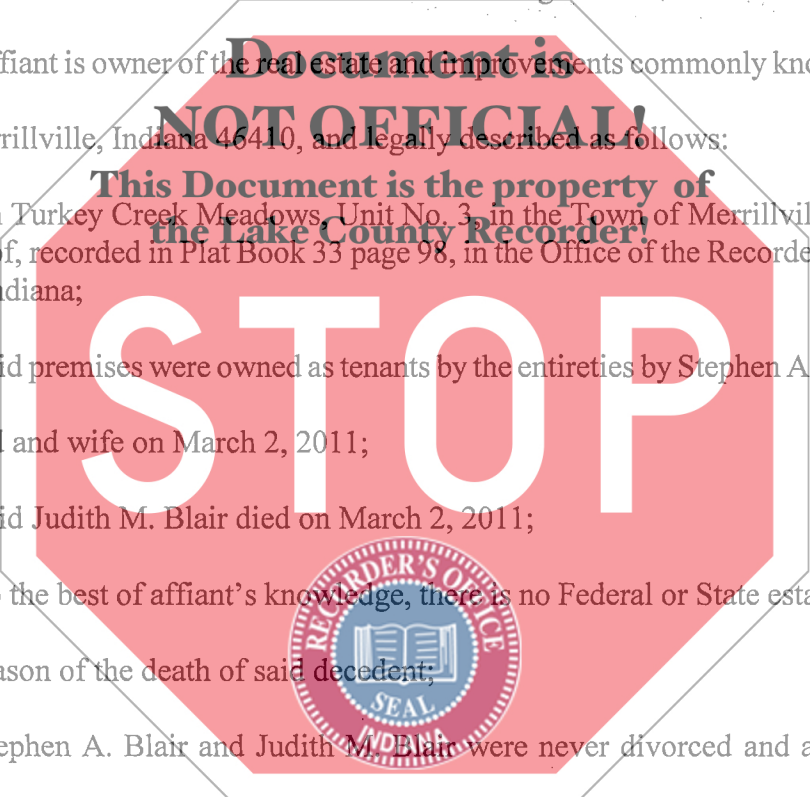
SURVIVORSHIP AFFIDAVIT

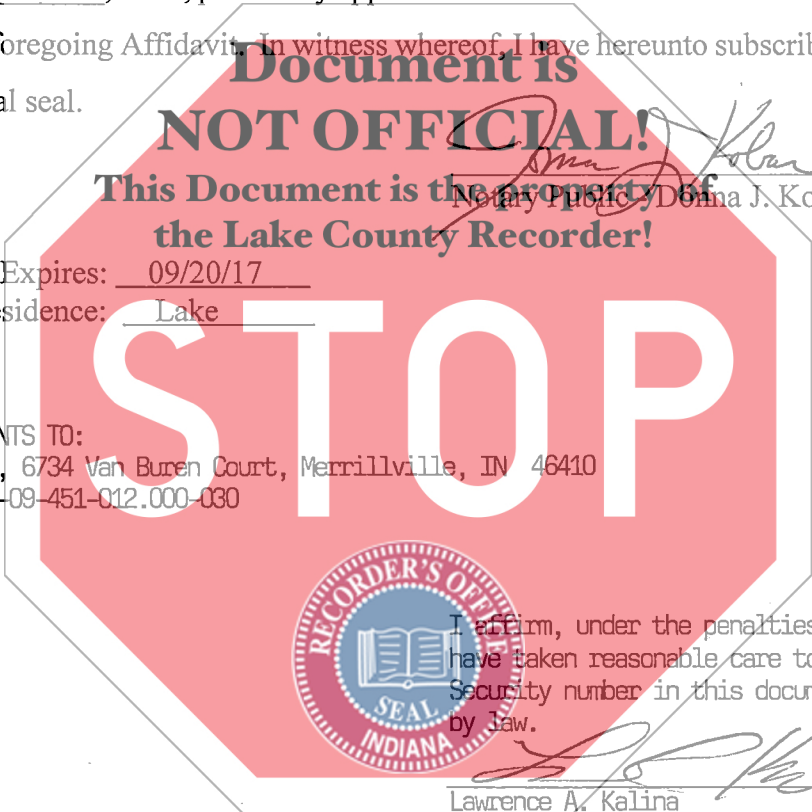
