Subject to all easements and restrictions of record and taxes.

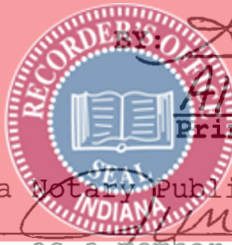

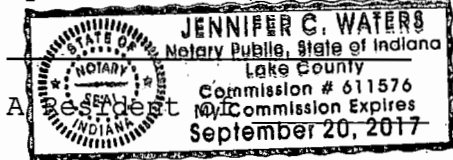
