- (3) for any other earth moving operation located on or bordering the lot or land herein described.

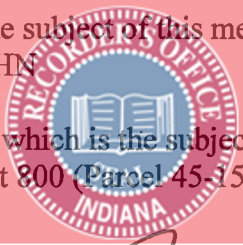
