You are hereby notified that St. Margaret - Hammond, 5454 Hohman Ave., Hammond, IN 46320-1931, intends to hold a Hospital Lien for all reasonable and necessary charges for hospital care, treatment, or maintenance of the above-listed patient subject to the limits and reductions of any benefits to which the patient is entitled under the terms of any contract, health plan, or medical insurance.
